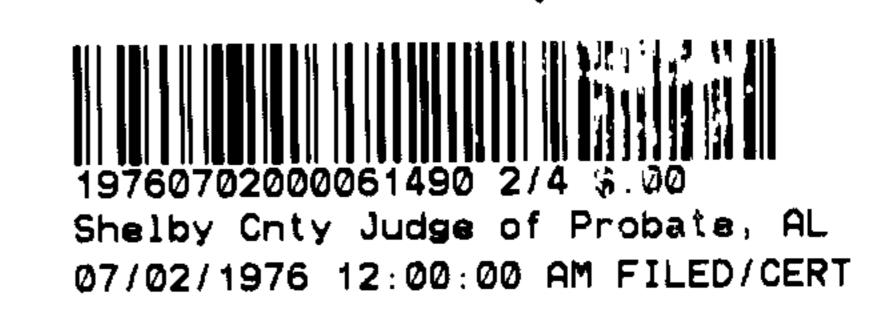

VANDERSLICE and wife, ALBERTINE VANDERSLICE; ELEANOR PEARL GOFF and husband, NORMAN DELTON GOFF; EDWARD VANDERSLICE and wife, PATRICIA VANDERSLICE; PAULINE MARTIN, a widow; LULA LEON KNOX and husband, JOHNNIE LLOYD KNOX; ETHEL V. CARDEN and husband, JAMES EDGAR CARDEN; BONNIE ODELL DAVIS and husband, EARMON CHARLES DAVIS; MILDRED A. A parcel of land in the SE corner of the NW4 of the NE4 of Section 18, Township 21, Range 2 West, more particularly described as follows: Commence at the SE corner of said forty and run thence North along the Eastern line of said forty 256 feet; thence South 89 deg. 45' West 440.7 feet, more or less, to the East margin of the right of way of what is known as the Birmingham-Montgomery Highway; thence in a Southeasterly direction along the east margin of said highway right of way 329 feet, more or less, to the South boundary line of said forty; thence East along the South boundary line of said forty 241 feet, more or less, to the point of beginning, containing 2.3 acres, more or less;

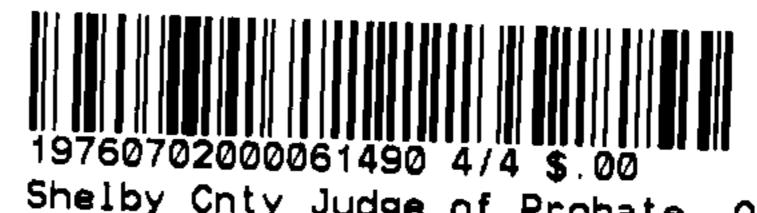
