WHEREAS, the Owners, in order to provide for the health, safety, comfort, convenience and general welfare of the public, desires to subject the hereinabove described land to the covenants, terms, conditions, restrictions and limitations hereinafter set forth:

NOW, THEREFORE, the undersigned Owners do hereby agree that the above described property shall be subject to the following covenants, terms, conditions, restrictions and limitations:

- (A) No residential dwelling house shall be erected on the above described property containing less than 1,300 square feet of heated living area.
- No lot shall be used except for residential purposes. No building shall be erected, altered, or placed on any lot other than one detached single-family dwelling not to exceed two stories in height. With the approval of the architectural control committee, there may be erected a detached garage and servants quarters of the same construction as the main dwelling and occupied by domestic servants employed on the premises only.
- 1. No building shall be erected, placed or altered on any lot until the construction plans and specifications and a plat showing the location of the structure have been approved by the architectural control committee as to quality of workmanship and materials, harmony of external design \* with existing structures, and location with respect to topography and finish grade elevations. No fence or wall shall be erected, placed or altered on any lot nearer to any street than the minimum building setback line unless similar approval shall be obtained as hereinafter provided.

- (H) No structure of a temporary character, trailer, basement, tent, shack, garage, barn or other outbuilding shall be used on any lot at any time as a residence; either temporarily or permanently.
- (i) No oil drilling, oil development operations, oil refining, quarrying or mining operations of any kind shall be permitted upon or in any lot, nor shall oil wells, tanks, tunnels, mineral excavations or shalls be permitted upon or in any lot. No derrick or other structure designed for use in boring for oil or natural gas shall be erected, maintained or permitted upon any lot.
- (J) No animals, livestock, or poultry of any kind shall be raised, bred or kept on any lot, except that dogs, cats, or other household pets may be kept provided that they are not kept, bred or maintained for commercial purposes.
- (K) No lot shall be used or maintained as a dumping ground; nor shall rubbish, trash, garbage or other waste be kept, except in sanitary containers. All incinerators or other equipment for the storage or disposal of such material shall be kept in a clean and sanitary condition.
- (L) No fence, wall, hedge or shrub planting which obstructs sight lines at elevations between 2 and 6 feet above roadways shall be placed or permitted to remain on any corner lot within the triangular area formed by the street property lines and a line connecting them at points 25 feet from the intersection of the street property lines extended. The same sight line limitations shall apply on any lot within 10 feet from the intersection of a street property line, with the edge of a driveway or alloy payone at.
