SHELBY COUNTY } KNOW ALL MEN BY THESE PRESENTS,

That in consideration of ---Two Thousand Seven Hundred Fifty and no/100 (\$2,750.00)--- DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we,
Joe M. Barnett, and wife, Kathleen Barnett
(herein referred to as grantors) do grant, bargain, sell and convey unto

Harold Leon Trice and wife, Julie Ann Trice

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

An undivided one/half interest in and to the following described property:

Commence at the Southeast corner of the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 4, Township 22 South, Range 2 West, and thence run West along the South line of said quarter-quarter section a distance of 804.14 feet to a point on the West right of way line of a paved road; thence continue in the same direction of 130.60 feet to the Southeast corner of property known as the Mose Cook lot; thence turn an angle of 94 deg. 30 min. to the right and run along the East line of said Mose Cook lot a distance of 126.60 feet to the Northeast corner of said Mose Cook lot; thence turn an angle of 92 deg. 25 min. to the left and run along an old fence row and along the North line of said Mose Cook lot a distance of 352.00 feet to the West line of said quarter-quarter section and an old fence row; thence turn an angle of 86 deg. 27 min. to the right and run North along the West line of said quarter-quarter section and along said old fence row a distance of 116.92 feet; thence turn an angle of 107 deg. 33 min. to the right and run a distance of 302.62 feet to the point of beginning of the lot herein described; thence continue in the same direction along the South property line of the lot herein described a distance of 210.00 feet to a point on the West right of way line of said paved road; thence run Northerly along the West right of way line of said paved road a distance of 105.00 feet; thence run in a Westerly direction, parallel with the South property line of the lot herein described a distance of 210.00 feet to a point; thence run in a Southerly direction parallel with the West right of way line of said paved road a distance of 105.00 feet to the point of beginning.

Subject to easements and rights of way of record.

TO HAVE AND TO HOLD to the said GRANTEES for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.
