C. & Delene Wilson to Union Oil Company of California, a California corporation, or its predecessor in title with the understanding that said Lease is assigned without warranty of any kind, expressed or implied, and without recourse of any kind on Union Oil Company of California, said assignment to be effective July 1, 1976.

In the event the aforesaid Jobber Sales Agreement is cancelled for any reason or terminates under its own terms, then this assignment will be considered as automatically cancelled, contemporaneously with such cancellation or termination, and Assignee on demand of Assignor will reassign said Lease to Assignor.

Assignor shall have and hereby is granted the unqualified rights and privilege to terminate this assignment at any time by giving Assignee at least thirty (30) days advance written notice in which event Assignee agrees to reassign said Lease Agreements to Assignor.
