A part of the NE $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Sec. 26, T21S, R1W, more particularly described as follows: Commence at the NW corner of said NE $\frac{1}{4}$  of NW $\frac{1}{4}$  of Sec. 26 and run South 1 deg. 51' East along West line a distance of 704.61 ft.; thence turn an angle of 98 deg. 56' to left and run 210 ft.; thence turn an angle of 98 deg. 56' to right and run South 1 deg. 51' East a distance of 260 ft. to point of beginning of the land herein described; thence continue in same direction a distance of 195.3 ft. to North margin of West College Street; thence turn an angle of 99 deg. 10' to left and run along North margin of West College Street a distance of 100.35 ft. to the SW corner of Whittemore lot; thence turn an angle of 85 deg. 22' left and run Northerly along West boundary of said Whittemore lot a distance of 200.18 ft.; thence turn an angle of 99 deg. 18' left and run Westerly a distance of 85.67 ft. to point of beginning.
