KNOW ALL MEN BY THESE PRESENTS, That the undersigned LARRY CROCKER and wife, MARTHA CROCKER; JIMMY SPAIN and wife, BILLIE RUTH SPAIN; A. C. CROCKER and wife, LILLIAN CROCKER; HAROLD CUMMINGS and wife, JANE CUMMINBS, for and in consideration of the sum of One Dollar (\$1.00) in hand paid by each of the undersigned to each of the other undersigned, the receipt and sufficiency of which is hereby acknowledged, and in further consideration of the mutual covenants and agreements set out herein, said parties do hereby agree, covenant and contract as follows:

1. There is hereby created an easement for ingress and egress in favor of all parties hereto, their heirs, successors, and assigns, twelve feet in width over the North 12 feet of the lot described on Exhibit "A" attached hereto and made a part and parcel hereof as fully as if set out herein, and that part of the East twelve feet thereof lying North of the "joint driveway" described thereon.

And said easement to also continue in favor of said parties hereto in an Easterly direction, twelve feet in width extending from a point where the joint driveway shown on said Exhibit "A" intersects the Eastern boundary of the lot described on said Exhibit "A", Easterly at its present location to the Samuel White lot.

2. It is understood and agreed that the owners of the lot described on Exhibit "A" shall have the right at any time they desire to do so to move the driveway shown as a "joint driveway" on Exhibit "A" attached hereto, to relocate the same across the North 12 feet of said lot and the East 12 feet thereof, as above provided; said easement as so relocated to be shown by broken line marks on said Exhibit "A".

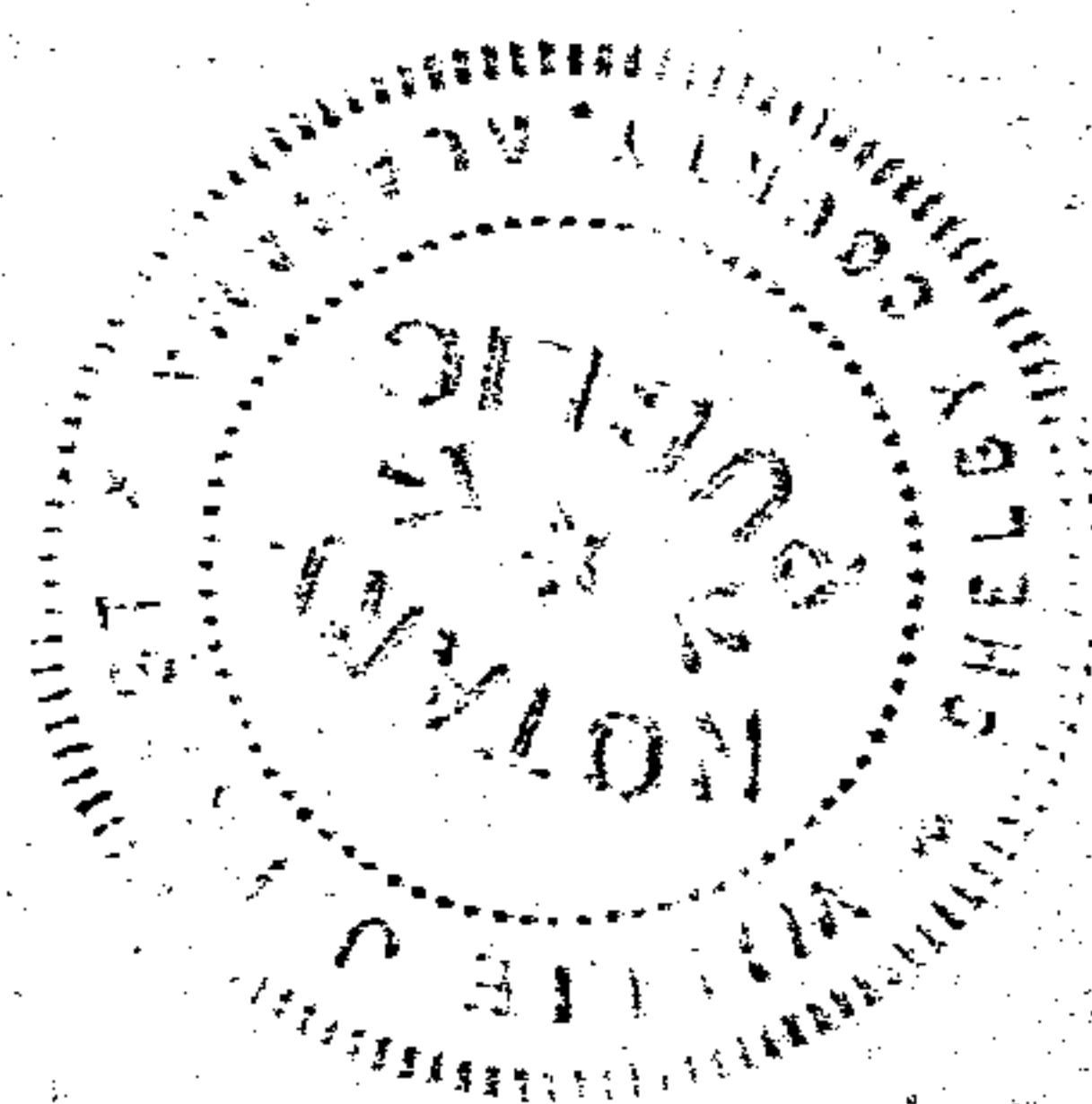
