Know All Men by These Presents, That

WHEREAS, on the 10 day of April 19 73, a decree was rendered by the Probate Court of said County for the sale of the lands hereinafter described and conveyed for the State and County taxes then due from McNeill Moore

the owner of said land for the costs and expenses thereof and thereunder.

AND WHEREAS, thereafter, to-wit, on the 21 day of May 19 73, said lands were duly and regularly sold by the Tax Collector of said county for taxes, costs and expenses, and at said sale O.V. Wood

McNeill Moore owner as aforesaid of said land, and all the right, title, interest and claim of the State and County on account of said taxes, or under said decree in and to the following described lands hereinafter referred to, to-wit:

Tract in SE corner SW $\frac{1}{4}$ of SW $\frac{1}{4}$, Sec. 28, Twp 21, Range 3 West, lying between Montevallo-Maylene Road Co. # 17, on E, the So (AGS) RR on W, land of Montevallo-Limestone Co., and So * a local rd or drive going from Co. Road # 17 across S RR to hse & other lands owned by grantor, 1.46 Ac, more or less

lying and being situate in said County and State, to have and to hold the same, the said rights, titles and interests unto himself the said O.V. Wood, and his heirs and assigns forever, but no right, title or interest of any reversioner or remainderman in said land is conveyed hereby.
