

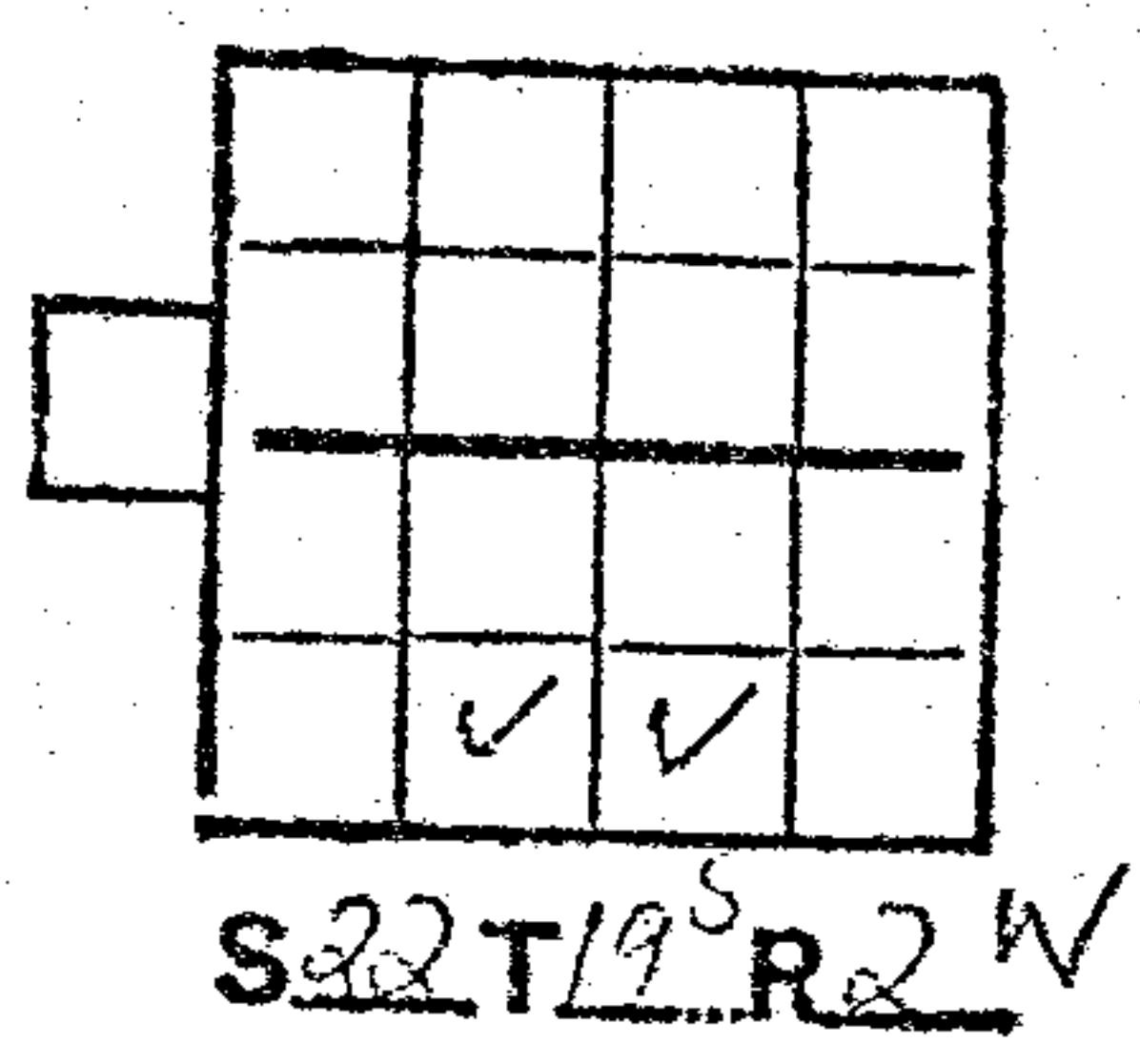

in consideration of the sum of One and No/100 Dollars (\$1.00), to it
in hand paid by Alabama Power Company, a corporation, the receipt whereof
is acknowledged, doeshereby grant to said Alabama Power Company, its
successors and assigns, the right to construct, install, operate and main-
tain, and the right to permit other corporations and persons to construct,
install, operate and maintain, along routes to be selected by the grantee,
(generally shown crosshatched on the attached drawing) its successors or
assigns, all poles, wires, conduits, cables, trans closures and other appli-
ances and facilities useful or necessary in connection therewith for the
overhead and underground transmission and distribution of electric power
and for the overhead and underground communication service, upon, over,
under and across the following described land, situated in Shelby
County, Alabama:

A parcel of land in SW $\frac{1}{4}$ of SE $\frac{1}{4}$ and a parcel of land in
SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 22, Township 19 South, Range 2 West,
more particularly described as follows: Commence at SW
corner of SW $\frac{1}{4}$ of SE $\frac{1}{4}$ for a point of beginning, thence
east 332 ft, thence left 79 degrees 44 minutes NEly 79.68
ft., thence left 10 degrees 16 minutes Nly 260 ft., thence
right 90 degrees Ely 10 ft., thence left 90 degrees Nly
393 ft. M/L to South R/W of Cahaba Valley Rd. (Shelby County
119) thence SWly along Rd. 850 ft. M/L to Bishop Creek,
thence SWly 800 ft. to South line of SE $\frac{1}{4}$ of SW $\frac{1}{4}$, thence East
800 ft. M/L to the point of beginning.

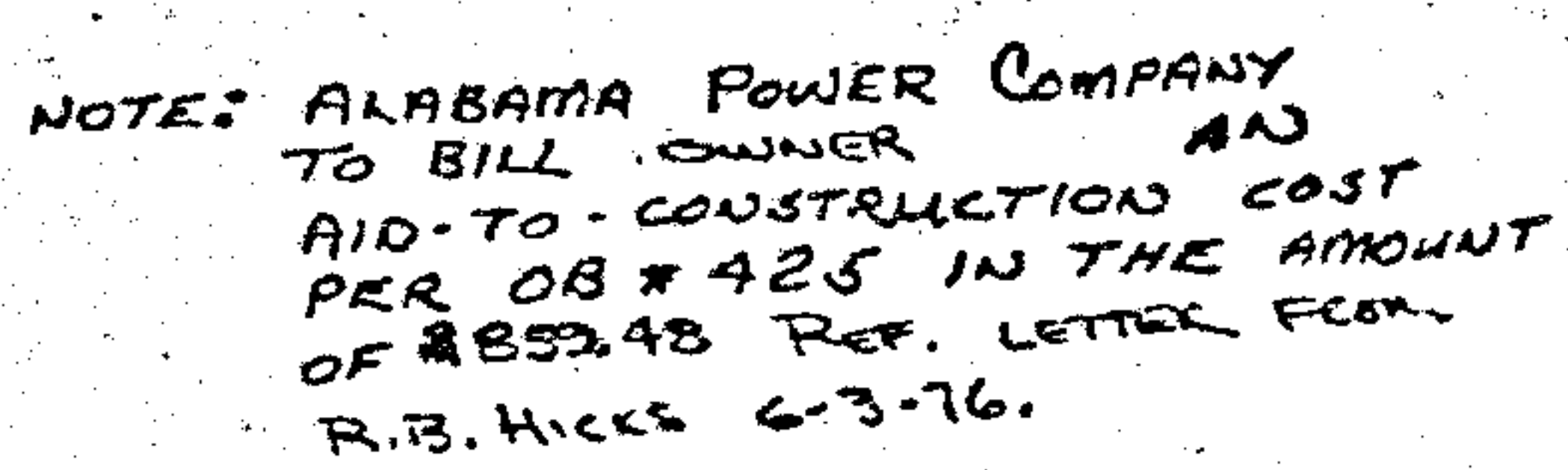

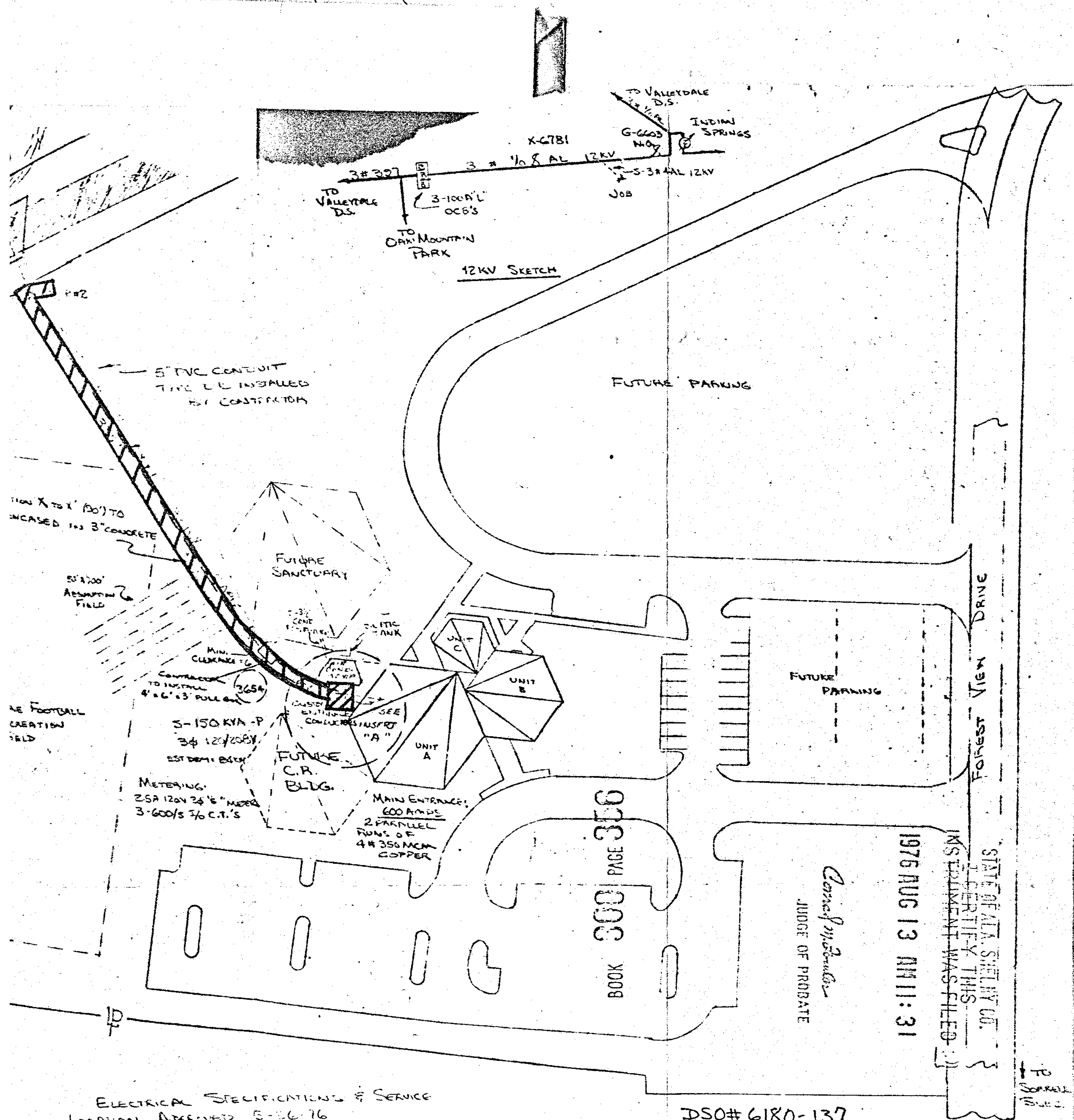

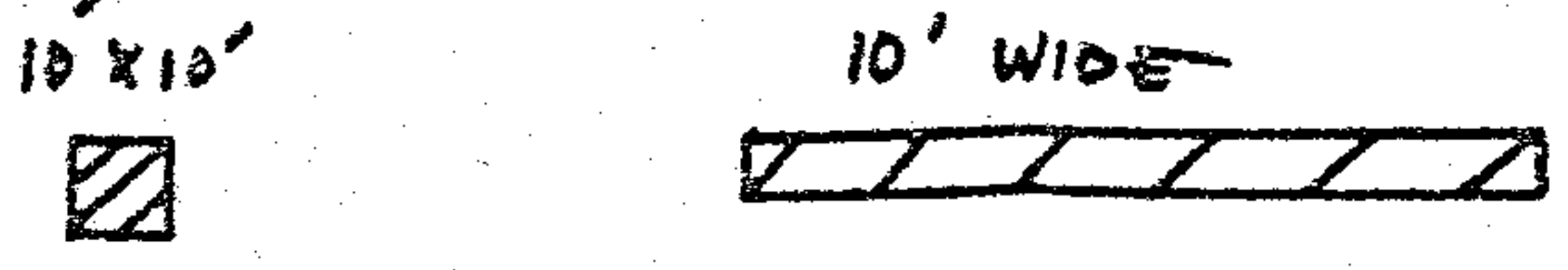
