A 50' wide roadway easement, the centerline of said easement being more particularly described as follows: From the northeast corner of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 28, Township 20 South, Range 3 West, Shelby County, Alabama, run in a westerly direction along the north line of said $\frac{1}{4}-\frac{1}{4}$ section for a distance of 315.00 feet, thence turn an angle to the left of $90^{\circ} 48' 15''$ and run in a southerly direction for a distance of 210 feet, thence turn an angle to the left of $89^{\circ} 11' 45''$ and run in an easterly direction for a distance of 150 feet, thence turn an angle to the right of $89^{\circ} 11' 45''$ and run in a southerly direction for a distance of 150.63 feet to the point of beginning, thence turn an angle to the left of $89^{\circ} 20'$ and run in an easterly direction for a distance of 165.22 feet, thence turn an angle to the right of $1^{\circ} 17'$ and run for a distance of 178.49 feet, more or less, to the centerline of Maylene Road (Shelby County Road No. 17) which is the end of said roadway easement.

Also, a 23 foot wide roadway easement, the north line of said easement being more particularly described as follows: From the northeast corner of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 28, Township 20 South, Range 3 West, Shelby County, Alabama, run in a westerly direction along the north line of said $\frac{1}{4}-\frac{1}{4}$ section for a distance of 315.00 feet, thence turn an angle to the left of $90^{\circ} 48' 15''$ and run in a southerly direction for a distance of 210.00 feet, thence turn an angle to the left of $89^{\circ} 11' 45''$ and run in an easterly direction for a distance of 150 feet, thence turn an angle to the right of $89^{\circ} 11' 45''$ and run in a southerly direction for a distance of 153.38 feet to the point of beginning, thence turn an angle to the right of $90^{\circ} 48' 15''$ and run in a westerly direction for a distance of 125 feet to the point of ending of said roadway easement.
