Smith and husband, Paul C Smith; Amelia F. Lum and husband, James G. Lum; Julia F. Wilson and husband, Hal Wilson; and Edgar G. Frsot and wife, Norma W. Frost,

(herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto

James E. Frost

(herein referred to as grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Begin at the Southeast corner of the NW¼ of the SW¼ of Section 13, Township 22 South, Range 3 West and run thence North along the East line of said quarter-quarter section a distance of 330 feet; thence run West, parallel with the South line of said quarter-quarter section, a distance of 660 feet, more or less, to a point on the West line of the East Half of said quarter-quarter section; thence run South along said West line of the East Half of said quarter-quarter section a distance of 330 feet to a point on the South line of said quarter-quarter section; thence run East along the South line of said quarter-quarter section a distance of 660 feet, more or less, to the point of beginning, subject to easements and rights of way of record, containing 5 acres, more or less.
