Before me, the undersigned authority, in and for said County and State, personally appeared ELLA SPEIGEL BRANTLEY, who, being known to me and being by me first duly sworn, deposes and says as follows:

That she is 44 years of age and presently resides at Route 2, Alabaster, Alabama; that she has been acquainted with the occupation, use and possession of the following described property for the last past 40 years:

All that part of the North 330 feet of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 13, Township 20 South, Range 3 West, that lies West of County Highway right of way, EXCEPT lot willed to Cornice Speigel Edwards and EXCEPT lot willed to Jack Speigel and EXCEPT lot willed to James Speigel.

Also a part of the SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 13, Township 20 South, Range 3 West, described as follows: Begin at the NE corner of said $\frac{1}{4}$ $\frac{1}{4}$ Section and run South along East boundary for 358 feet; thence in a Northwesterly direction 607 feet to Coates Branch; thence in a Northerly direction along said branch to North line of said $\frac{1}{4}$ $\frac{1}{4}$ Section; thence East along North line of said $\frac{1}{4}$ $\frac{1}{4}$ Section to point of beginning.

Subject to Easement to Plantation Pipe Line Company.

Affiant remembers when the above property, along with other property, was bought by her father, Bert Speigel from W. L. Coates in 1942. And that upon the execution and delivery of said deed affiant's father took possession of said land, constructed a house thereon and lived on said land with affiant's Mother and affiant until affiant's father died in June of 1963. After his death affiant's Mother continued to live in said house, and in 1968 affiant and her husband, Lucious Grover Brantley, moved in said house and did some remodeling on the house, and on April 1, 1968, affiant's Mother sold said house to affiant and her husband by deed recorded in Deed Book 252, page 462, and the consideration for said deed was paid in full. Affiant and her husband continued to live in said house, and affiant's Mother, Mrs. Bert Speigel, was living there when she died on June 25, 1971.

Further deposing, affiant says that at the present time she and her husband own said land in fee simple, and that since the time she first knew the land it has been owned by the present owners and their predecessors in title and has been occupied by them actually, exclusively, openly, notoriously, hostilely and continuously and she has never heard the title of the present owners or their predecessors in title questioned in any way.


