Before me, the undersigned authority in and for said County and State personally appeared EMILY CARTER BELL who is known to me and who being first by me duly sworn, deposes and says as follows:

My name is EMILY CARTER BELL. I am 63 years of age and am a child of John Carter who is deceased. I know of my own knowledge that the sole and surviving heirs of law and next of kin of John Carter are the following: W.W. CARTER whose wife is OLIVIA; EMILY CARTER BELL, being myself, and husband JOSEPH BELL; LILLIE MAE C. BOSTIC whose husband is A.L. BOSTIC and MARY LOU CARTER ANDREWS, being a widow. My mother's name was Phoebe Roberta Carter. I understand that it has appeared on the records as Mrs. John Carter, Phoebe Roberta Carter and as Ruby Carter, all being one and the same person.

It is common knowledge in my family that my father purchased said land in the year 1935. It is shown by deed recorded in Deed Book 94, Page 561, in the Probate Office of Shelby County, Alabama. I am familiar with the line of the property being sold to Marvin E. Hall and Mary E. Hall by the above named heirs. I know the description in said Hall deed covers one and the same parcel of land which my father went into possession/in 1935 and we have continued in the possession each and every year until this very day. Said land being described as follows:

A lot in the Southwest quarter of the Northwest quarter, Section 9, Township 24 North, Range 12 East described as follows: Begin at the Northeast corner of the Bice lot on the Northwest line of Highway 25, thence Northwest 242 feet, thence North 55 feet 9 inches, thence Northwest 14.5 feet to the Southern Railroad Right-of-Way, thence Northeast along the Right-of-Way 161.5 feet, thence Southeast 295 feet to the Northwest Right-of-Way of Highway 25, thence Southwest along the Highway Right-of-Way 210 feet to the point of beginning; approximately 1.5 acres.

I know of my own knowledge that no one has ever disputed our possession or contested our title to said land and we have held the same openly, peacefully, notoriously, adversely and have had exclusive possession from the date my father purchased the same until this present day



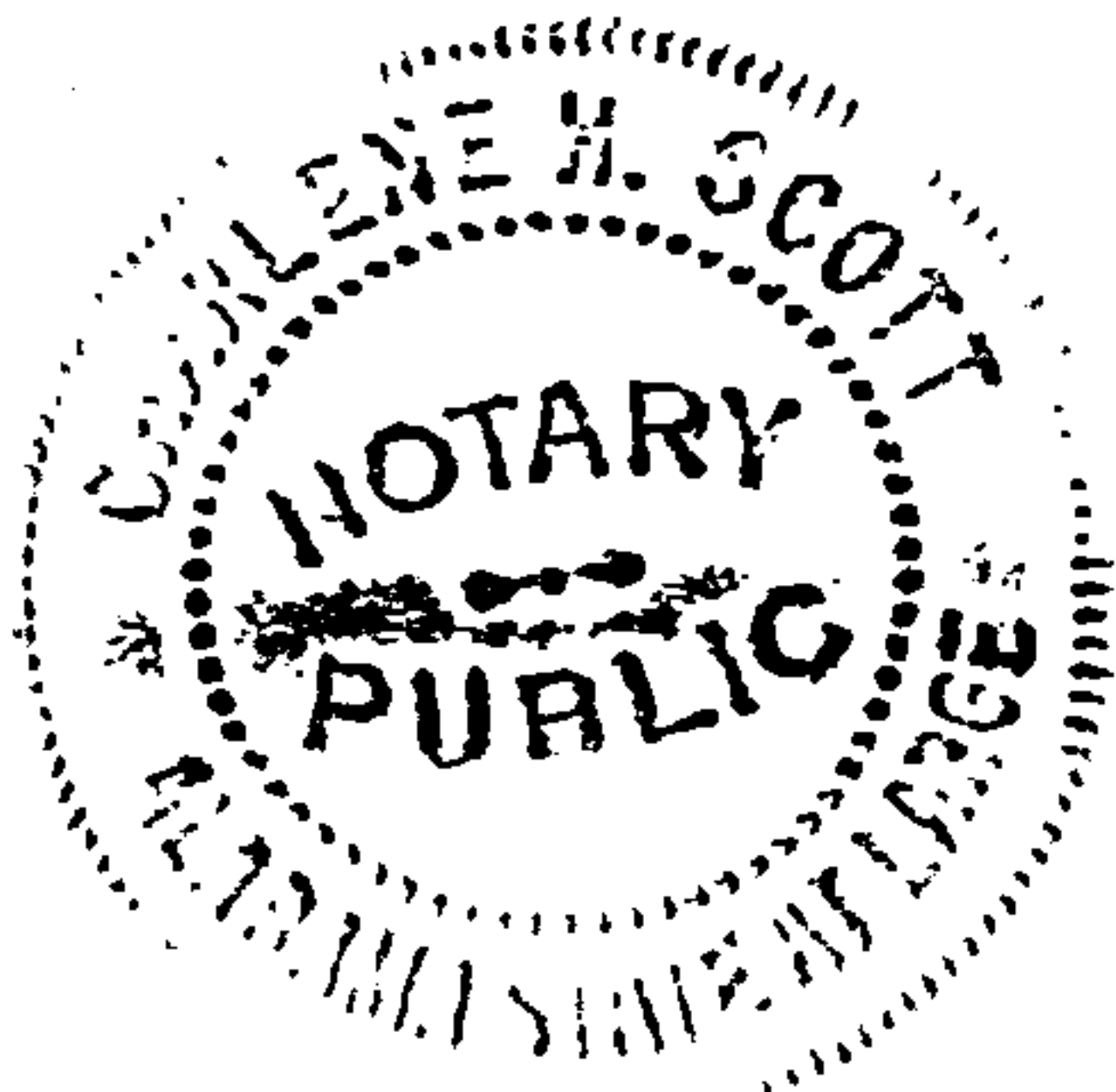
