KNOW ALL MEN BY THESE PRESENTS: That Whereas, the undersigned, Dolphus W. Humphries, is this day conveying certain real estate in Shelby County, Alabama, as set out and described in Exhibit "A", attached hereto, subject to an easement 60 feet wide over and across the property this day conveyed, from Arrowhead Lane on the eastern side of said property to the western boundary thereof and the property still owned by the undersigned, Dolphus, W. Humphries, as laid out on that presently unrecorded boundary map of D. W. Humphries' property prepared by Allen Whitley Land Surveyor and Engineer on September 20, 1976.
