PARTIAL RELEASE


KNOW ALL MEN BY THESE PRESENTS, that whereas A. M. Harper, W. K. Murray, J. Reese Murray, J. B. Davis and A. M. Harper, Trustee executed a certain mortgage to the undersigned, which mortgage is recorded in Mortgage Book 325, page 680, in the Probate office of Shelby County, Alabama.


NOW, THEREFORE, in consideration of the sum of \$1.00 and other good and valuable considerations, receipt whereof is hereby acknowledged, the undersigned does hereby release from the lien and operation of said mortgage the following described real estate, to-wit:

From the NW corner of the NE 1/4 of Section 5, Township 20 South, Range 1 East, run Eastwardly along the North line of said 1/4 section a distance of 868.38 feet to a point on the West right-of-way line of a county road; thence right 94° 19' a distance of 176.22 feet along the West right-of-way line of said county road to the point of beginning; thence left 10° 27' a distance of 367.23 feet along the chord of a curve to the left on said right-of-way line; thence left 08° 09' a distance of 302.70 feet along the chord of a curve to the left on said right-of-way line; thence left 105° 17' a distance of 726.45 feet; thence left 132° 29' a distance of 890.0 feet to the point of beginning of the property herein described. Situated in Shelby County, Alabama.

This release shall not in any way impair or effect the right of the mortgagee to hold the remainder of the premises conveyed by said mortgage and not hereby released as security for that part of the mortgage indebtedness remaining unpaid.


