WHEREAS, the parties hereto own 160 acres of real estate jointly and each of them desire that no person other than said parties shall own an interest in the same unless all agree to sell said interest to a third party. Said real estate being described as follows:

SW $\frac{1}{4}$  of SE $\frac{1}{4}$ ; E $\frac{1}{2}$  of SW $\frac{1}{4}$ ; NW $\frac{1}{4}$  of SW $\frac{1}{4}$ , Section 18, Township 20, Range 1 West, Shelby County, Alabama.

It is agreed by the parties hereto that should any one of the undersigned desire to sell their interest in the above described real estate, said person shall give written notice to each of the remaining parties of their desire to sell their interest in the same. The remaining parties shall have sixty (60) days from the date of said notice in which to exercise their option to purchase said interest of the party desiring to sell.

The parties hereto further agree that should either one of them desire to sell their interest in the above described real estate, they will give the other parties hereto the right of first refusal to purchase the same at the fair market value at the time of sale. If a price cannot be agreed upon between the parties hereto, the same shall be submitted to three competent persons, one chosen by the person desiring to sell, one by the remaining property owners and a third by the two; and the decision of the majority shall be conclusive; and the expense of such persons shall be borne equally by the parties hereto.
