KNOW ALL MEN BY THESE PRESENTS, That Gordon A. Taylor, Churchill G. Carey, Eugene L. Amber, J. C. Tyler, Jr., John D. Uible and John H. Rogers, not individually, but as Trustees of GUARDIAN MORTGAGE INVESTORS, a Massachusetts Business Trust, under Declaration of Trust dated March 29, 1966, as amended, and their respective successor Trustees under said Declaration of Trust (herein referred to as the "Trust"), acknowledge receipt of good and valuable consideration, and in consideration thereof, the undersigned do hereby release and satisfy that certain Real Property mortgage dated August 23, 1971, and executed by FLETCHER PROPERTIES OF ALABAMA, INC., which said mortgage was recorded in the office of the Judge of Probate of Shelby County, Alabama, in Mortgage Book 318, Page 712, and refiled for record in the office of the Judge of Probate of Jefferson County, Alabama, in Real Volume 744, Page 262, insofar as said mortgage covers the following described land situated in Shelby County, Alabama, to-wit:

Lot . 13 . . . , Block . 3 . . . , according to the plat of Applecross a sub-division of Inverness, as recorded in Map Book . 6 . . . , Page . 42B . , in the office of the Judge of Probate of Shelby County, Alabama.

Provided, however, that said lien shall be effective and remain upon the balance of the land described in said mortgage the same as though this release had not been executed.

All persons dealing with Guardian Mortgage Investors must look solely to the trust property for the enforcement of any claims against Guardian Mortgage Investors.
