Part of the Southwest quarter of the Northwest quarter of Section 14, Township 18 South, Range 1 East, more particularly described as follows:

Commence at the Southwest corner of said quarter-quarter section and run East along South line of said quarter-quarter section 891.90 feet to the Southeast corner of B. Kendrick property; said southeast corner being the point of beginning of herein described property.
