
KNOW ALL MEN BY THESE PRESENTS, for and in consideration of the sum of \$8,250.00 dollars, cash in hand paid to the undersigned by the State of Alabama, the receipt of which is hereby acknowledged, we (I), the undersigned, grant-Nell Dexter Waite and husband Robert S. Waite; Robert S. Waite or(s), and Frank W. Hardie, Jr., As Trustees Under have (has) this day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto the State of Alabama the following described property, lying and being Shelby County, Alabama, and more particularly described as

follows: and as shown on the right-of-way map of Project No. I-65-2(37) as recorded in the Office of the Judge of Probate of Shelby County, Alabama:

Beginning at the southwest corner of the SW% of SW%, Section 32, T-19-S, R-2-W; thence easterly along the south line of said SW% of SW%, the south property line, a distance of 986 feet, more or less, to the northeast property line; thence northwesterly along said northeast property line, a distance of 504 feet; thence westerly, parallel to the south line of the SW% of SW%, said Section 32 and the south line of the SE% of SE%, Section 31, T-19-S, R-2-W, a distance of 910 feet, more or less, to a point that is 200 feet easterly of and at right angles to the centerline of the right lane of Project No. I-65-2(37); thence southerly along a curve to the right (concave westerly) having a radius of 4019.72 feet, parallel to the certerline of said right lane, a distance of 494 feet, more or less, to the south line of the SE% of SE%, said Section 31, the south property line; thence easterly along said south property line, a distance of 96 feet, more or less, to the point of beginning.
