Before me, the undersigned authority, a Notary Public, State of Alabama at Large, personally appeared Kenneth L. Mullins who, known to me, did upon oath depose and say:

My name is Kenneth L. Mullins.
I am acquainted with that property deeded by Nettie Trucks, a widow, to the Deacons of The Helena Baptist Church, December 19, 1933, which property is recorded in Deed Book 97, page 110, in the Office of the Judge of Probate of Shelby County, Alabama, and said property is described as follows:

A part of the S $\frac{1}{2}$ of the SW $\frac{1}{4}$ of Section 15, Township 20, Range 3 West, described as follows: Commence at a point where the Southerly line of F. F. Mullins' property (formerly owned by Ida Smith) intersects the Easterly line of Main Street in the Town of Helena, run thence Southerly along the Easterly line of Main Street a distance of 125 feet, run thence Easterly and parallel with the Southerly line of said F. F. Mullin's property a distance of 200 feet, run thence Northerly and parallel with the Easterly line of Main Street a distance of 125 feet to the Southerly line of said F. F. Mullins' property, run thence Westerly along the Southerly line of the said F. F. Mullins' property a distance of 200 feet to the point of beginning, situated Shelby County, Alabama.

I have resided in Helena for more than the last 49 years and I am a member of The Helena Baptist Church and I have attended the same for more than 49 years.

I am also acquainted with land owned by G. T. Kirkpatrick situated in the northeast corner of the intersection of Main Street, Town of Helena and the Helena-Pelham Road (Shelby County 52) which lies south of The Helena Baptist Church property. The Helena Baptist Church property which was obtained by the said church from Nettie Trucks, as referred to above, lies north of the said Kirkpatrick property, is not adjacent thereto, and is north of property purchased by the said church from W. J. Strickland. In other words, property purchased by the said church from the said W. J. Strickland lies between property purchased by the said church from Nettie Trucks in 1933, and the said above referred to property of G. T. Kirkpatrick.

Said property deeded by Nettie Trucks, as referred to above, to the Deacons of The Helena Baptist Church December 19, 1933, does not overlap on the northern boundary of the said referred to Kirkpatrick property. There never has been any dispute concerning the said properties or any boundary or boundary-line dispute pertaining to the said properties whatsoever to my knowledge, nor have I ever heard of any dispute.
