KNOW ALL MEN BY THESE PRESENTS That in consideration of TEN DOLLARS and other good and valuable consideration to the undersigned grantor Morris C. Benners, Jr., trustees, the receipt whereof is acknowledged, the said grantors do grant, bargain, sell, convey and quitclaim unto the said Jack J. Benners and Morris C. Benners, Jr., in trust nevertheless, under that certain Trust Indenture dated December 24, 1976, between grantors (as Settlers) and grantees (as Trustees), the following described real estate, situated in Shelby County, Alabama, to-wit:

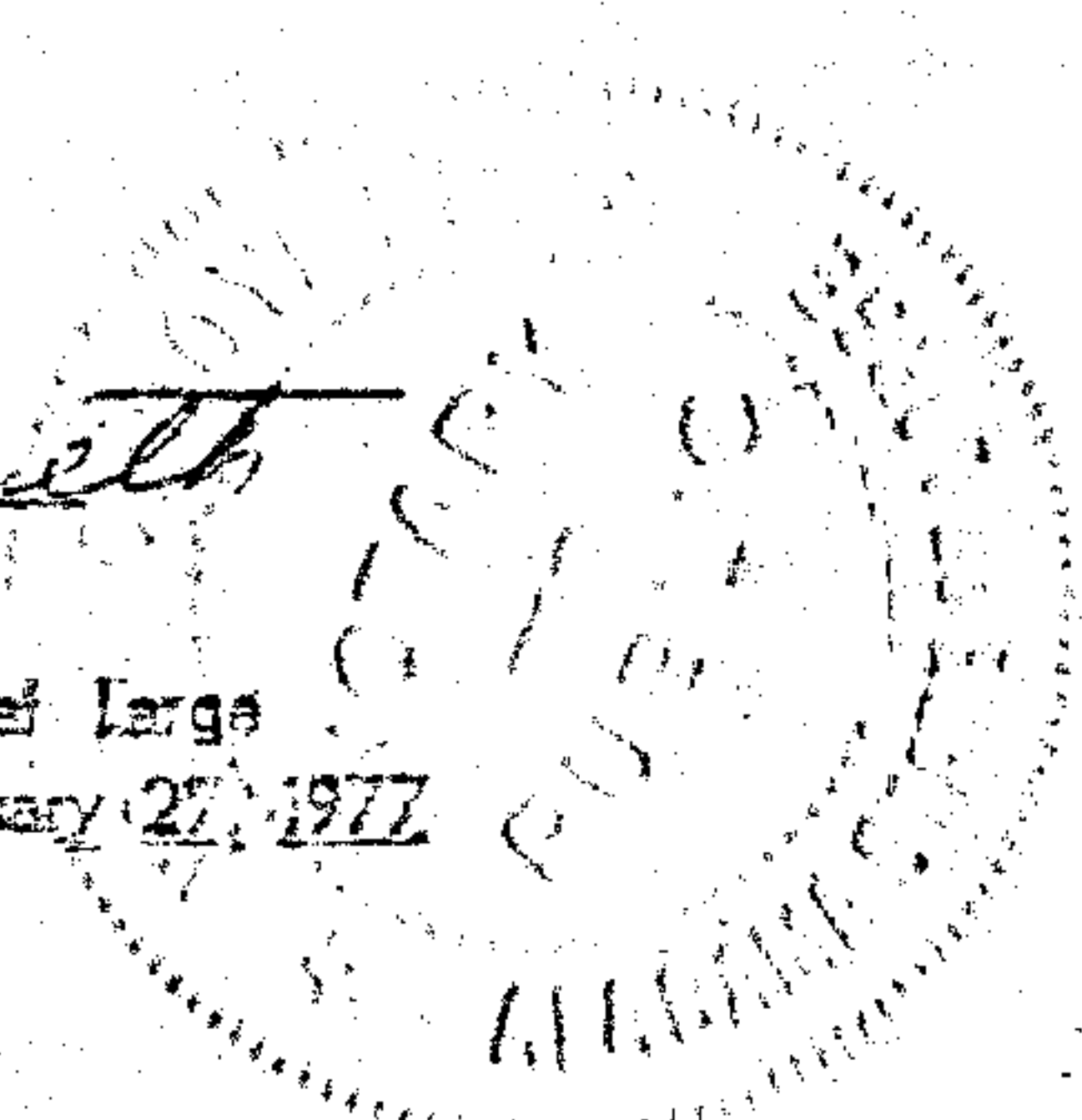
