

Commence at the Northeast corner of the northeast Quarter of the Northwest Quarter of Section 33, Township 19 South, Range 2 East, Shelby County, Alabama, thence proceed South 2 degrees 36 minutes West for a distance of 945.45 feet to the point of beginning of land herein described.
