"Beginning at the Northeast corner of the SE 1/4 of the SW 1/4 of Section 15 Township 20 Range 3 West, and go thence North along the center line of said Section 85 feet, thence South 89 degrees, 48 minutes West 266 feet to the point of beginning of the property hereby conveyed and which point is marked by an Iron Stake, Continue thence South 89 degrees, 48 minutes West 361 feet to the East margin of Rolling Mill Street, Thence South 0 degrees 51 minutes East along the East margin of Rolling Mill Street 334 feet, thence North 86 degrees 55 minutes East 379 feet to the West margin of a ditch, thence North along the West margin of said ditch 313 feet to the point of beginning. Located in the SE 1/4 of SW 1/4 and the NE 1/4 of the SW 1/4 of Section 15 Township 20 Range 3 West."
