WHEREAS, said parties now desire to amend the same,

NOW THEREFORE, in consideration of the premises, the parties
hereto do hereby amend said trust agreement by deleting therefrom

Section c of paragraph 8 thereof in its entirety and substituting

"c. To sell, convey or exchange any part or all of the real property held in the trust, and the signature of the corporate trustee, acting alone, on any conveyance or other document purporting to convey title to any part or all of said real property shall be fully effective to transfer and convey the entire interest described in said conveyance or other document, and no party shall be required to inquire into the propriety of or the authority for such action."
