KNOW ALL MEN BY THESE PRESENTS, That for VALUE RECEIVED, the undersigned
CENTRAL STATE BANK, a corporation, does hereby release and discharge from the
lien of that certain mortgage recorded in Mortgage Book 316 261

in the office of the Probate Judge of Shelby County, Alabama, a part only of the
real estate therein described, which part so released is hereby specifically
described as follows, viz:

All merchantable pulpwood and timber located on hereafter described property
to be removed within one year. This form will release all timber but does not
release mortgage on land.

Ten acres in the SE corner of the SE $\frac{1}{4}$ of NE $\frac{1}{4}$ and the NW $\frac{1}{4}$ of SE $\frac{1}{4}$, except ten acres
in the SW corner thereof, Section 14, Township 24 North, Range 15 East.

Except highway and public road rights of way and except transmission line permits
to Alabama Power Company.

described other than that hereby expressly released, be and remain unimpaired
