Before me, a Notary Public in and for said County in said State, personally appeared Frank W. Wheeler, who is known to me, and who being by me first duly sworn, deposes and says as follows:

My name is Frank W. Wheeler, and I reside at Route 1, Wilsonville, Shelby County, Alabama. I am a Registered Land Surveyor and have been for the past 18 years.

I previously made a survey dated September 5, 1973, for Mr. Fred Hanby, being a survey of the NE $\frac{1}{2}$  of NW $\frac{1}{2}$  of Section 30, Township 20 South, Range 1 East, Shelby County, Alabama. I established all four corners of said quarter-quarter section, marking the same with iron pipes.

I previously, some ten or more years ago, made a survey for Mr. Ike A. Whorton or some members of his family situated in Section 29, Township 20 South, Range 1 East, and as a part of said survey, I ran and marked a line between said Section 29 and said Section 30, Township 20 South, Range 1 East. The Whorton property, or a part of it, consists of the West Half of NW $\frac{1}{4}$  of said Section 29.

I found and verified the NW corner of said Section 29, which is also the Northeast corner of said Section 30, as shown on a drawing made by me of a Fred Hanby Estate of Section 30, Township 20 South, Range 1 East, Shelby County Alabama, it being marked by a stake and rock pile. I also found and verified the Southwest corner of SW $\frac{1}{4}$  of NW $\frac{1}{4}$  of said Section 29, it being also the SE <sup>corner</sup> of the SE $\frac{1}{4}$  of NE $\frac{1}{4}$  of said Section 30, the same being marked with an iron pipe, and I ran and marked the line between said points, said line being the West line of the NW $\frac{1}{4}$  of said Section 29 and also being the East line of the NE $\frac{1}{4}$  of said Section 30. Shortly after I ran and marked this line Mr. Arthur Whorton painted the line.

I believe my survey to be accurate, and so far as I know, it is not questioned by any of the persons concerned.
