I came to Shelby County in 1925 and at that time, Emma and Will Drake were living on the above property. In 1939 the property sold for its taxes to E. L. M. Wallace. E. L. M. Wallace never moved onto the property. In fact, Will and Emma Drake continued to live on the same continuously. Later in 1939 E. L. M. Wallace made a deed to Will Drake and wife, Emma Drake. There was a house located on the above property at that, time as I previously stated, and Will Drake and Emma Drake were actually living in the house on the above described property when they got the deed from E. L. M. Wallace. Emma and Will Drake continued to live on the property first above described, occupying the house on the property, farming and gardening portions of the property, and claiming the same against the entire world. This continued uninterrupted up until the time of Will Drake's death a year or two after they got the deed in 1939. After Will Drake died; his widow, Emma Drake, continued to live on the first above described property, farming portions of the same and living in the house located on the same continuously, unterrupted, for each and every year up until about 2 or 3 years ago when Emma Drake became ill and had to move to Birmingham with her daughter. From the time she moved out of the house situated on the property, it has been occupied continuously and exclusively by persons renting from Emma Drake. There have never been any disputes whatsoever, concerning the occupation, ownership, use or possession of said property, and since 1939 no other person, firm or corporation has been in possession of said property or any part thereof, with the exception of Will Drake and Emma Drake. A portion of the first above described property was conveyed to Dorothy Merritte in May, 1976 by deed recorded in Deed Book 298, page 851.
