

CATES MILK HAULING - Description of a 60.0 foot easement for roadway:

30.00 feet either side of a center-line described as: Commence at the Northeast corner of the NW $\frac{1}{4}$  of the NW $\frac{1}{4}$ , Sec. 19, T-21-S, R-1-E, thence run West along the North line of said  $\frac{1}{4} \frac{1}{4}$  Section a distance of 270.93 feet to the point of beginning; thence turn an angle of 16 deg. 29 min. 37 sec. to the left and run a distance of 531.26 feet to the P. C. of a curve; thence continue along said curve (whose Delta Angle is 28 deg. 20 min. 5 $\frac{1}{2}$  sec. to the right, Radius is 197.97 feet, Tangent is 50.00 feet, Length of Arc is 97.95 feet) to the P. T.; thence continue in the same direction a distance of 58.61 feet to the P. C. of a curve; thence continue along said curve (whose Delta Angle is 18 deg. 20 min. 11 sec. to the right, Radius is 309.79 feet, Tangent is 50.00 feet, Length of Arc is 98.1 $\frac{1}{4}$  feet) to the P. T.; thence continue in the same direction a distance of 63.52 feet to the P. C. of a curve; thence continue along said curve (whose Delta Angle is 77 deg. 59 min. 59 sec. to the right, Radius is 61.7 $\frac{1}{4}$  feet; Tangent is 50.00 feet; Length of Arc is 84.03 ) to the P. T.; thence continue in the same direction a distance of 130.61 feet to the North line of the NW $\frac{1}{4}$  of the NW $\frac{1}{4}$ , said Sec. 19, which point is 239.28 feet East of the Northwest corner of said Sec. 19; thence continue in the same direction a distance of 35.76 feet to the P. C. of a curve; thence continue along said curve (whose Delta Angle is 59 deg. 08 min. 28 sec. to the right, Radius is 88.12 feet, Tangent is 50.00 feet, Length of Arc is 90.95 feet) to the P. T.; thence continue in the same direction a distance of 118.38 feet to the P. C. of a curve; thence continue along said curve (whose Delta Angle is 22 deg. 32 min. left, Radius is 250.98 feet; Tangent is 50.00 feet; Length of Arc is 98.70 feet) to the P. T.; thence continue in the same direction a distance of 235.1 $\frac{1}{4}$  feet to the P. C. of a curve; thence continue along said curve

(whose Delta Angle is 19 deg. 32 min. 30 sec. to the left, Radius is 290.35 feet; Tangent is 50.00 feet; Length of Arc is 99.02 feet) to the P. T.; thence continue in the same direction a distance of 251.39 feet to the P. C. of a curve; thence continue along said curve (whose Delta Angle is 110 deg. 45 min. 23 sec. left; Radius is 138.03 feet; Tangent is 200.00 feet, Length of Arc is 266.92 feet) to the P. T.; thence continue in the same direction a distance of 252.15 feet to the East right-of-way line of Alabama Hwy. No. 25, and the point of ending. Situated in the NW $\frac{1}{4}$  of the NW $\frac{1}{4}$  of Section 19 and the SW $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 18, T-21-S, R-1-E, Shelby County, Alabama.
