

ITEM ONE

I direct that my Executrix hereinafter named shall pay from my estate all of my just debts including the expenses of my last illness and burial as soon after my death as is practicable.

ITEM TWO

All the rest, residue and remainder of my estate of every nature whatsoever and wheresoever situated, real, personal and mixed, I give, devise and bequeath to Jean Mitchell, Clinton Benton, Raleigh Benton, and Evelyn Shartel, share and share alike.

ITEM THREE

I hereby nominate and request the appointment of Jean Mitchell to be the Executrix of this my Last Will and Testament and I hereby exempt said Executrix from the filing of an inventory, from the giving of a bond, from the filing of a final settlement and from the doing and performing of every act I can legally exempt her of. I also grant to and vest in my said Executrix full power and authority to sell at private sale and to convey, lease, exchange, mortgage, pledge or otherwise alienate any and all of the assets of my estate on such terms as she may deem to be proper in her sole discretion without
