This affidavit is given for the purpose of clearing title to the property described in Lawyers Title insurance binder and for the purpose of inducing them to issue a title insurance policy.



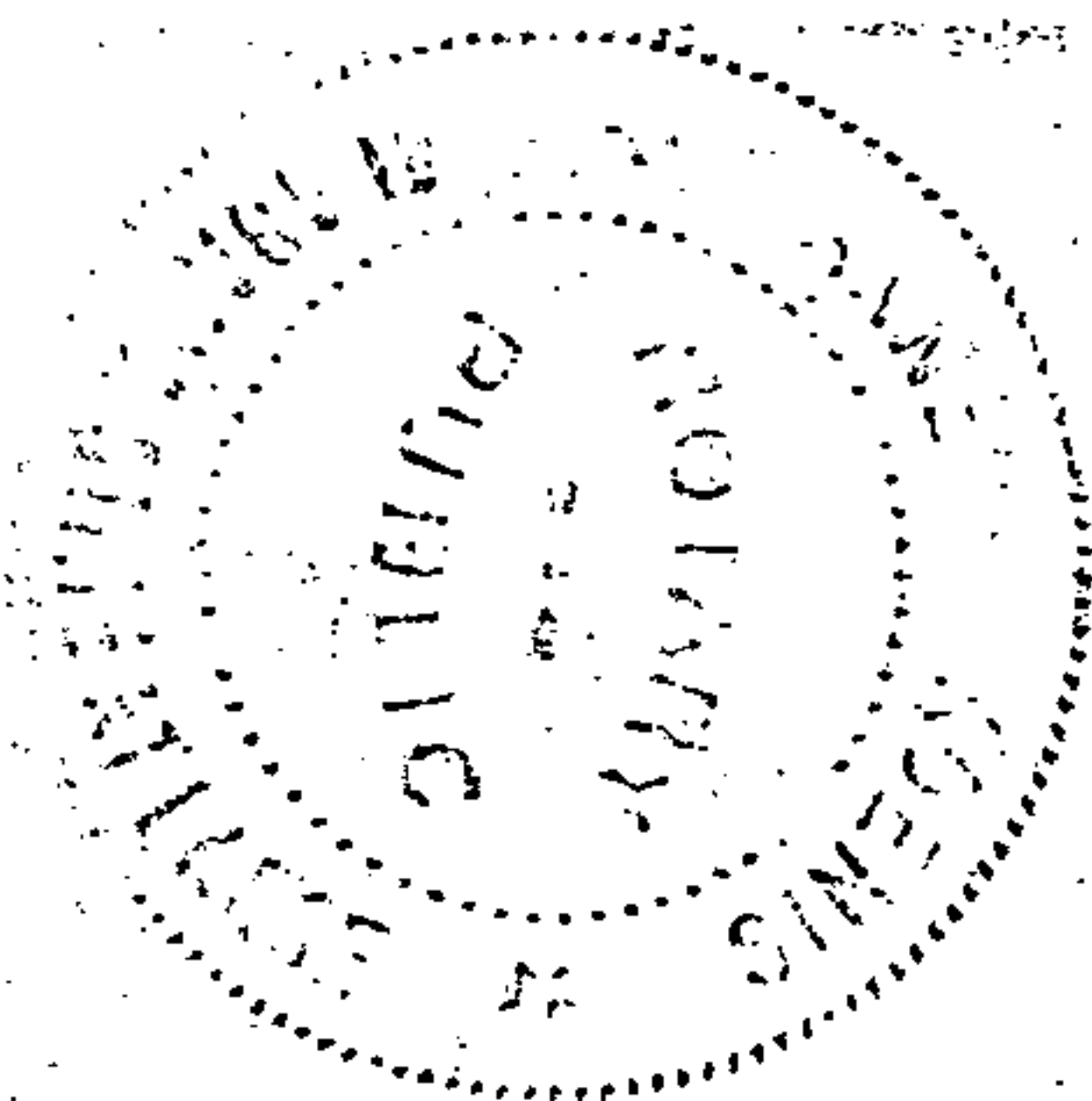
