He came over here regularily to see about the property and looked after it even before Mr. Luck died. I recall that there was a serious forest fire in 1958 and Mr. Gordon came over to check on the damage done to the trees on the property. Mr. Gordon also rechecked the lines from time to time and in 1967 put up

After Mr. Luck's death, my husband and I asked Mr. Gordon about the purchase of the property, and he gave us the same answer as Mr. Luck, but he did ask us to continue to look after the property for them and gave us permission to use it.
