KNOW ALL MEN BY THESE PRESENTS,

That in consideration of other valuable considerations and Ten and No/100 (\$10.00)----- DOLLARS

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Bertha Nabors, a widow; Rosie Elliott, a widow; Larry Calhoun and wife, Kathy Calhoun; and Otis Calhoun and wife, May Frances Calhoun (herein referred to as grantors) do grant, bargain, sell and convey unto

Larry Calhoun and wife, Kathy Calhoun

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Our undivided interests in and to the following described property:

Begin at the SW corner of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 36, Township 20, Range 3 West and go thence North 89 deg. East 264 feet; thence North 31 deg. and 40 min. East 315 feet to point of beginning of lot herein described; thence north 31 deg. and 40 min. East 105 feet; thence South 37 deg. and 30 min. East 210 feet to the North margin of the Harpersville Public Road; thence South 31 deg. and 40 min. West along the North margin of said road 105 feet; thence North 37 deg. and 30 min. West 210 feet to the point of beginning. Said lot being in Section 36, Township 20, Range 3 West, and containing 1/2 acre, more or less. Subject to easements and rights of way of record and subject to mortgage indebtedness.

The grantors warrant that Phil Calhoun and his wife, Marie Calhoun, who formerly owned the above described property are both deceased, said Phil Calhoun having died intestate while a resident of Shelby County, Alabama, on September 17, 1968, and said Marie Calhoun having died while a resident of Shelby County, Alabama, on June 6, 1975; that said Marie Calhoun was an unmarried woman at the time of her death; that said Phil Calhoun and said Marie Calhoun had only three children ever born of them, namely, the grantors, Bertha Nabors and Rosie Elliott, and Robert Calhoun, who is deceased; that said Robert Calhoun died intestate while a resident of Shelby County, Alabama, on February 19, 1975, he being survived by his widow, Geneva Calhoun and three children, namely, the grantor, Larry Calhoun and the grantor, Otis Calhoun, and one other child, a minor, Paul Calhoun, said three children being the only children ever born of said Robert Calhoun. And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said GRANTEES, their heirs and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.
