

Begin at the southwest corner of Section 25, Township 20 South, Range 3 West; thence North 89° 13' East along the south line of said section a distance of 258.5 feet to a point on the old right of way of Highway U.S. 31; thence at an angle of 75° 33' left a distance of 340.0 feet to the original southwest corner of Lot 4; thence at an angle of 75° 33' right a distance of 79.6 feet to a point on the new right of way of U.S. 31 for a point of beginning; thence continuing on a prolongation of said line a distance of 120.4 feet to the southeast corner of Lot 4; thence at an angle of 75° 33' left a distance of 129.9 feet to a point; thence at an angle of 90° left a distance of 116.6 feet to a point on the highway right of way; thence at an angle of 90° left a distance of 160.0 feet along the highway right of way to the point of beginning.
