KNOW ALL MEN BY THESE PRESENTS: That in consideration of Twelve Thousand Five Hundred Dollars (\$12,500.00), to the undersigned grantors, in hand paid by the grantee herein, the receipt whereof is acknowledged, we, Will D. Nix and wife, Lorraine Nix; Lydia N. Anderson, a widow; Edgar Roy Nix and wife, Mary Junita Nix; Mack Aron Nix and wife, Lurlene Nix; John W. Nix and wife, Cherry Lou Nix; George Archie Nix and wife, Faye Nix; Lula Mae Sherrer and husband, Bobby E. Sherrer; and James Leon Nix and wife, Betty Joyce Nix; (herein referred to as grantors), grant, bargain, sell and convey unto Peggy Nix, (herein referred to as grantee), our undivided interest in and to the following described real estate, situated in Shelby County, Alabama, to-wit:

A portion of the NE $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 16, Township 22 South, Range 3 West lying East of Shelby County Road 15, more particularly described as follows: Commence at the southeast corner of the Northeast quarter of the Southwest quarter of said Section, Township, and Range, and run thence North along the East boundary of said quarter-quarter section 986.52 feet for the point of beginning of the tract of land herein conveyed. Continue thence North along said East boundary of said quarter-quarter section 328.84 feet; thence to the left at an angle of 88 degrees 43 minutes westwardly 1264.28 feet to a point on the East boundary of Shelby County Road No. 15; thence to the left at an angle of 96 degrees 50 minutes 05 seconds southwardly along said East boundary of said right of way 329.46 feet; thence to the left at an angle of 88 degrees 12 minutes 07 seconds eastwardly 1243.98 feet to the point of beginning, containing 9.46 acres more or less and subject to the easements, rights of ways, and restrictions of record.

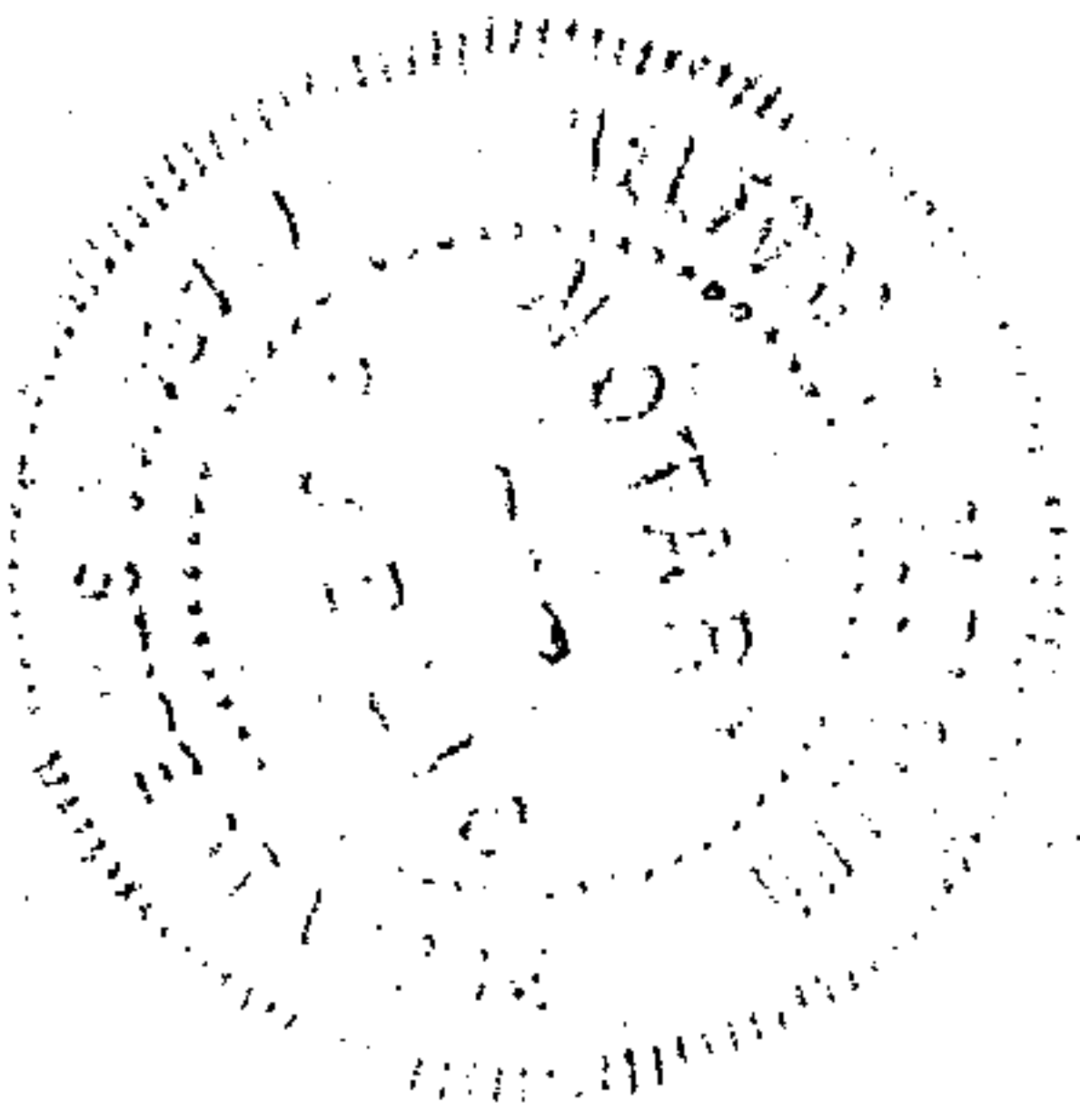
