KNOW ALL MEN BY THESE PRESENTS, That in consideration of FORTY-NINE THOUSAND NINE HUNDRED DOLLARS AND NO CENTS (\$49,900.00) to the undersigned GRANTOR, 2154 TRADING CORPORATION, a corporation D/B/A INVERNESS, (herein "GRANTOR"), in hand paid by the GRANTEE herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto

ROBERT CRAIG FULFORD AND WIFE, DEBORAH SMITH FULFORD (herein referred to as "GRANTEE") for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in Shelby County, Alabama, to-wit:
