does by these presents, grant, bargain, sell and convey unto the said UNIVERSITY OF MONTEVALLO

the following described real estate, situated in Shelby County, Alabama, to-wit:

A tract of land situated in the Northwest 1/4 of the Northeast 1/4 of Section 6, Township 20 South, Range 2 West, Shelby County, Alabama, and more particularly described as follows: Commence at the Northwest corner of the Northwest 1/4 of the Northeast 1/4; thence run in a Southerly direction along the West line of said 1/4-1/4 section a distance of 562.69 feet; thence an angle left of 88 degrees 34 minutes 18 seconds and run in an Easterly direction a distance of 50.01 feet to the point of beginning; thence continue in an Easterly direction a distance of 285.14 feet; thence an angle left of 90 degrees and run in a Northerly direction a distance of 332.60 feet to a point on the South right of way line of Oak Mountain Park Road; thence an angle left of 91 degrees 54 minutes 49 seconds as measured to tangent of a curve to the left; said curve having a radius of 545.24 feet and subtending a central angle of 18 degrees 52 minutes 19 seconds; thence run in a Southwesterly direction along the arc of said curve a distance of 179.55 feet; thence from tangent to said curve, continue in a Southwesterly direction a distance of 106.55 feet to the beginning of a curve to the left; said curve having a radius of 25.0 feet and subtending a central angle of 70 degrees 38 minutes 34 seconds; thence run in a Southerly direction and parallel to the West line of said Northwest 1/4 of the Northeast 1/4, a distance of 235.68 feet to the point of beginning.
