We, Joe A. Scotch and wife Peggy P. Scotch

for and in consideration of the sum of One dollar and no/100-

Dollars (\$ 1.00) to US in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to set poles, guys and anchors in line and to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles upon, over,

under and across the following described lands situated in Shelby

County, Alabama:

A parcel of land located in the W 1/2 of SW 1/4, Section 7, Township 19 South,

Range 1 West, more particularly described as follows: Commence at the southeast

corner of the NW 1/4 of SW 1/4 of said Section 7, thence north 322.4 feet along

the east line of said forty, thence 91° 36' 30" left 820.70 feet, thence 40° 20'

left 506.41 feet, thence 84° 09' 30" right 29 feet for a point of beginning,

thence continue last described course 30 feet, thence 95° 50' 30" right 97 feet,

thence 84° 09' 30" right 30 feet, thence 95° 50' 30" right 97 feet to the point

of beginning.

It is agreed that in the event said poles and appliances interfere with the

construction of any buildings and/or improvements in the future that may be

erected on above described land, the grantee will relocate, one time at its

expense, said poles and appliances on said land so as not to interfere with said

buildings and/or improvements, and consent is hereby given the grantee to so

relocate said poles and appliances on said land. The easement does not
become effective until recorded

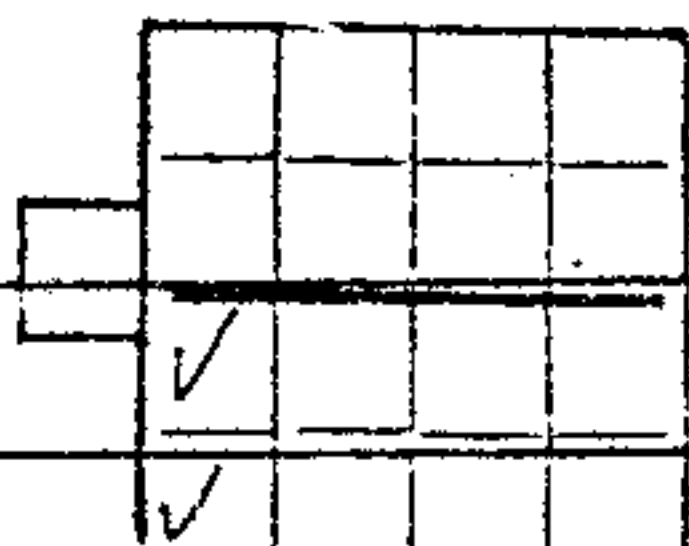
In the event it becomes necessary or desirable for Alabama Power Company to move its lines of poles and appliances in connection with the construction or improvement of any public road or highway in proximity to its said power lines, the said Company is hereby granted the right to relocate its said lines of poles and appliances on lands of grantors hereinabove described, provided, however, the said Company shall relocate its said line of poles at a distance not greater than ten feet outside the boundary of the right of way of any such public road or highway as established or re-established from time to time.

Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever.
