

AMENDMENT TO REAL ESTATE MORTGAGE

WHEREAS, by a Real Estate Mortgage dated the 8th day of May 1975, recorded in Book 346, Page 5, Probate Office of Shelby County, Alabama, the undersigned therein and herein called Mortgagors mortgaged the property therein described to Cumberland Capital Corporation, therein and herein called Mortgagee, to secure the indebtedness therein described; and

WHEREAS, said Real Estate Mortgage has been amended by those documents recorded in Book \_\_\_\_\_, Page \_\_\_\_\_, Book \_\_\_\_\_, Page \_\_\_\_\_, in the aforesigned Probate Office; and

WHEREAS, on said Mortgage there appears the phrase, or a similar phrase, reading substantially as follows: "The outstanding unpaid principal balance will not exceed \$ 7,000.00 and mortgage tax paid on the aforesigned amount; and

WHEREAS, Mortgagors desire that the above described Mortgage secure, without limitation, all sums now or hereafter owing to Mortgagee under the "Open End Credit Plan -- Revolving Loan Agreement" therein described; and

WHEREAS, to amend said Mortgage and provide for the payment of the mortgage tax on all subsequent advances, this instrument is executed.

NOW, THEREFORE, FOR AND IN CONSIDERATION of \$1.00 cash in hand paid and other good and valuable considerations, the receipt and sufficiency of all of which is hereby acknowledged by said Mortgagors, the said Mortgagors do hereby agree that the above described Real Estate Mortgage be and the same is hereby amended as follows:

- (1) That any statement or phrase therein which undertakes to limit the amount secured thereunder be and the same is hereby amended so as to remove therefrom any such limitation;
- (2) That it is the Mortgagors intent that said Real Estate Mortgage secure any and all sums without limitation now or hereafter owing by Mortgagors to Mortgagee under the "Open End Credit Plan -- Revolving Loan Agreement" as in said Mortgage described;
- (3) That the advance being made with the execution of this document and on which mortgage tax is paid with the recording hereof, is in the amount of \$8,002.50; (Included are all advances heretofore made on which mortgage tax has not been paid.)
- (4) That mortgage tax due on all advances hereafter made to Mortgagors during the preceding twelve (12) months ending each August 31, shall be paid by Mortgagee in each September hereafter and the amount of such mortgage tax shall be added to the account of Mortgagors.

Except as stated herein, said Real Estate Mortgage shall remain in full force and effect.


