## DISCHARGE OF BANKRUPT

3. All creditors whose debts are discharged by this order and all creditors whose judgments are declared null and void by paragraph 2 above are enjoined from instituting or centinuing any action or employing any process to collect such debts as personal liabilities of the bankrupt whose name is marked on the above list.

4.No assets were found over and above exemptions and liens which could be sold for the benefit of unsecured creditors.
