AFFIDAVIT

Before me, the undersigned Notary Public in and for said County in said State, personally appeared ROBERT A. ADAMS, JOHN F. ADAMS, and VERA WHETSTONE ADAMS, who are known to me, and who, by me being first duly sworn, deposed and stated the following:

1. J. P. Adams was the record owner of the following described real estate situated in Shelby County, Alabama:

Parcel # 1:

Lots 9 and 10, Block 2 according to the Map of Land of G. A. Nabors as recorded in Map Book 3, Page 33, Probate Office of Shelby County, Alabama.
