(herein referred to as grantors) do grant, bargain, sell and convey unto

Grover H. Metcalf and wife, Mildred G. Metcalf
(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Commence at the NW corner of NW¼ of NW¼, Section 9, Township 20, Range 1 East, thence go East along the North section line approximately 210 feet to the point on said line where the property now owned by Harry Good joins property conveyed to grantors herein by Charlie L.
