KELLEY; JERRY WAYNE PARTRIDGE and wife, DEBRA PARTRIDGE; MARY JO BRASHER and husband, JOHNNY BRASHER; Claude Partridge being the widower of Flora Partridge, deceased, who died in December of 1962; and Margie Carr, Melba Whitehead, Shirley Kelley, Jerry Wayne Partridge and Mary Jo Brasher being the only children and sole heirs and next of kind of Flora Partridge, deceased, (herein referred to as grantors) do grant, bargain, sell and convey unto


