Before me, the undersigned Notary Public for the state of Alabama, at large, personally appeared W. E. Allen. who being by me duly sworn doth depose and say as follows:

My name is W.E. Allen. I know Nadine Belcher Christie formerly Nadine Prescott Belcher, and I am familiar with the property owned by her that is described as follows:

Begin at NE corner of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 24, Township 20 South, Range 4 West, and go West along the North boundary of said $\frac{1}{4}$ - $\frac{1}{4}$ Section for 522.75 feet to the point of beginning; thence continue along this line for 594.11 feet, thence turn an angle of 90 deg. 00 min. left in a Southerly direction for 220 feet; thence turn an angle of 90 deg. 00 min. left in an Easterly direction for 594.11 feet; thence turn an angle of 90 deg. 00 min. left in a Northerly direction for 220 feet to the point of beginning, containing 3.0 acres, more or less, as surveyed by James A.
