We, Horace L. Thacker and wife, E. Margaret Thacker and Southern National bank,

As Mortgagee

for and in consideration of the sum of Three Thousand Six Hundred Dollars (\$3,690.00)  
to us Ninety and No/100---- in hand paid by Alabama Power Company, a corporation, the receipt whereof is ac-  
knowledgeed, do hereby grant to said Alabama Power Company, its successors and assigns, the right to  
construct, operate and maintain electric transmission and communication lines and all towers, poles,  
conduits, conductors, cables, insulators, anchors, guy wires, counterpoise conductors, and all other ap-  
pliances necessary or convenient in connection therewith from time to time over, under and across, a

strip of land seventy-five (75) feet in width, as said strip is now located by the final location survey thereof heretofore made by said Company, over, under and across the lands of which it is hereinafter described as being a part, together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof for the purposes above described, including the right of ingress and egress to and from said strip and the right to cut, remove, or otherwise kill, and keep clear by any means, including chemicals, all trees and undergrowth and all other obstructions under, on or above said strip and danger trees adjacent thereto which now or may hereafter injure, endanger or interfere with any of the works on said strip, and the right to install, maintain and use anchors and guy wires on land adjacent to said strip, and the right to install grounding devices on grantors' fences now or hereafter located on such strip and on fences or other structures of grantors now or hereafter located adjacent to such strip, and the right to prevent the use of such strip as a parking area for automobiles or other vehicles, as a storage area for machinery or materials, or as a road other than a road crossing such strip at a location which does not endanger or interfere with works that have been or may at some future date be constructed on such strip, said strip and the lands of which the same is a part being described as follows:

Northeast Quarter of Southeast Quarter (NE $\frac{1}{4}$  of SE $\frac{1}{4}$ ) of Section 27, Township 19  
South, Range 1 West, Shelby County, Alabama.

Commence at the Northwest corner of the Southeast Quarter of the Northwest Quarter of Section 34, Township 19 South, Range 1 West; thence run East along the North boundary line of said quarter-quarter a distance of 37.5 feet to a point; thence turn an angle to the left of 90 degrees 00 minutes and run North 01 degrees 36 minutes West a distance of 370.2 feet to a point; thence turn an angle to the right of 53 degrees 44 minutes and run North 52 degrees 08 minutes East a distance of 2683.9 feet to a point; thence turn an angle to the left of 18 degrees 28 minutes and run North 33 degrees 40 minutes East a distance of 908.8 feet, more or less, to a point on the South boundary line of the Grantor's property, such point being the point of beginning of the right of way herein described; therefrom, the strip lies 37.5 feet on each side of a center line and the continuations thereof which begins at such point of beginning and runs North 33 degrees 40 minutes East a distance of 385.1 feet to a point; thence such center line turns an angle to the left of 10 degrees 02 minutes and runs North 23 degrees 38 minutes East a distance of 746 feet, more or less, to a point on the North boundary line of the Grantor's property, such point being the point of ending of the right of way herein described. TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever.

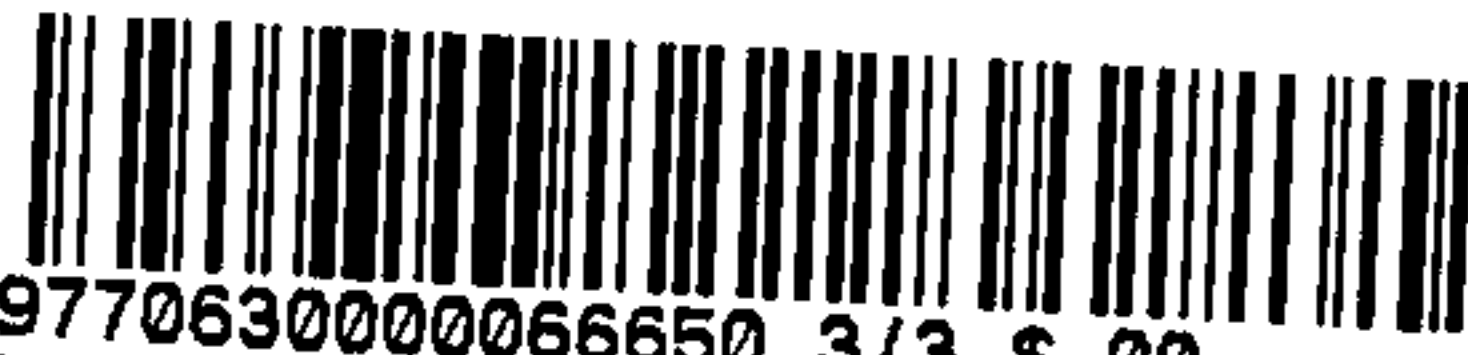
