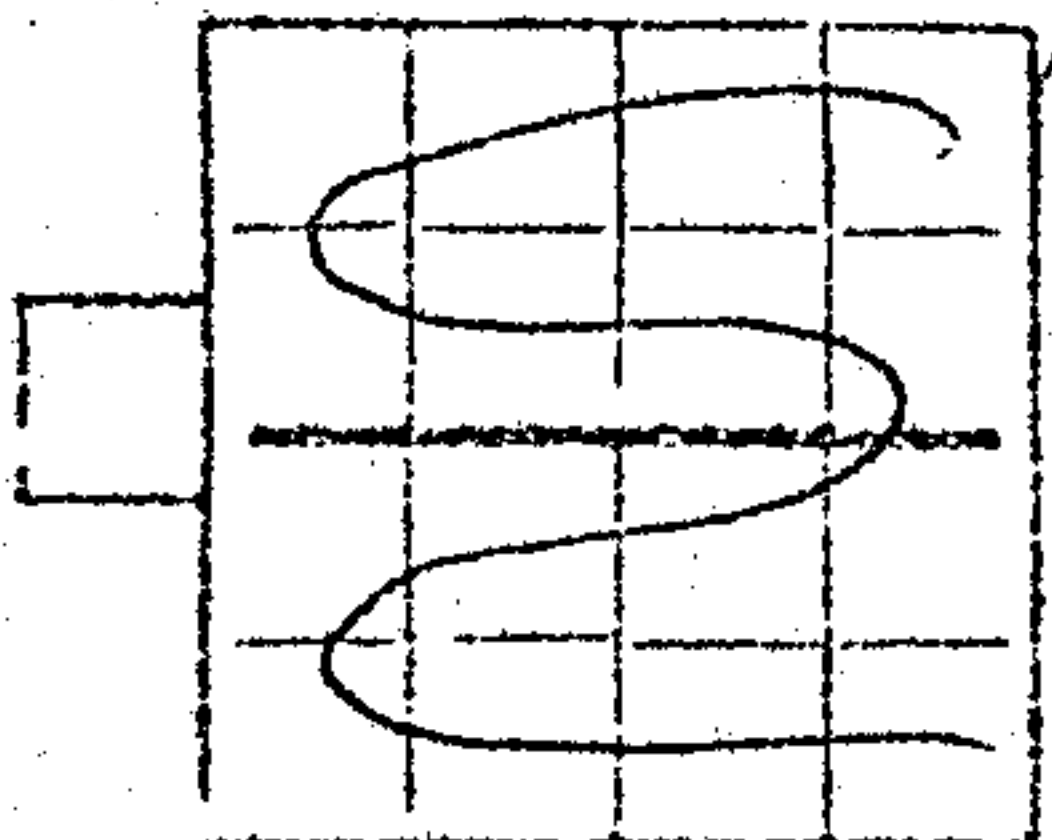

 East by Nora Whatley lands

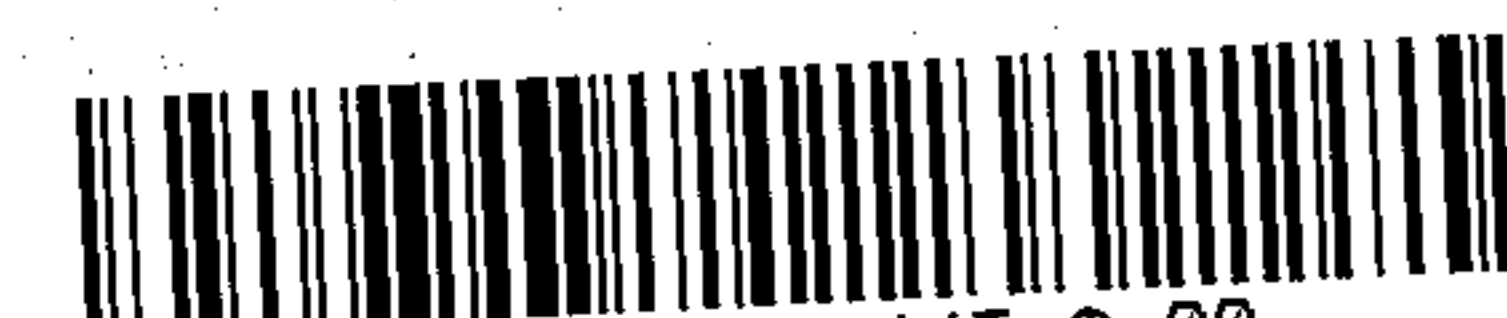

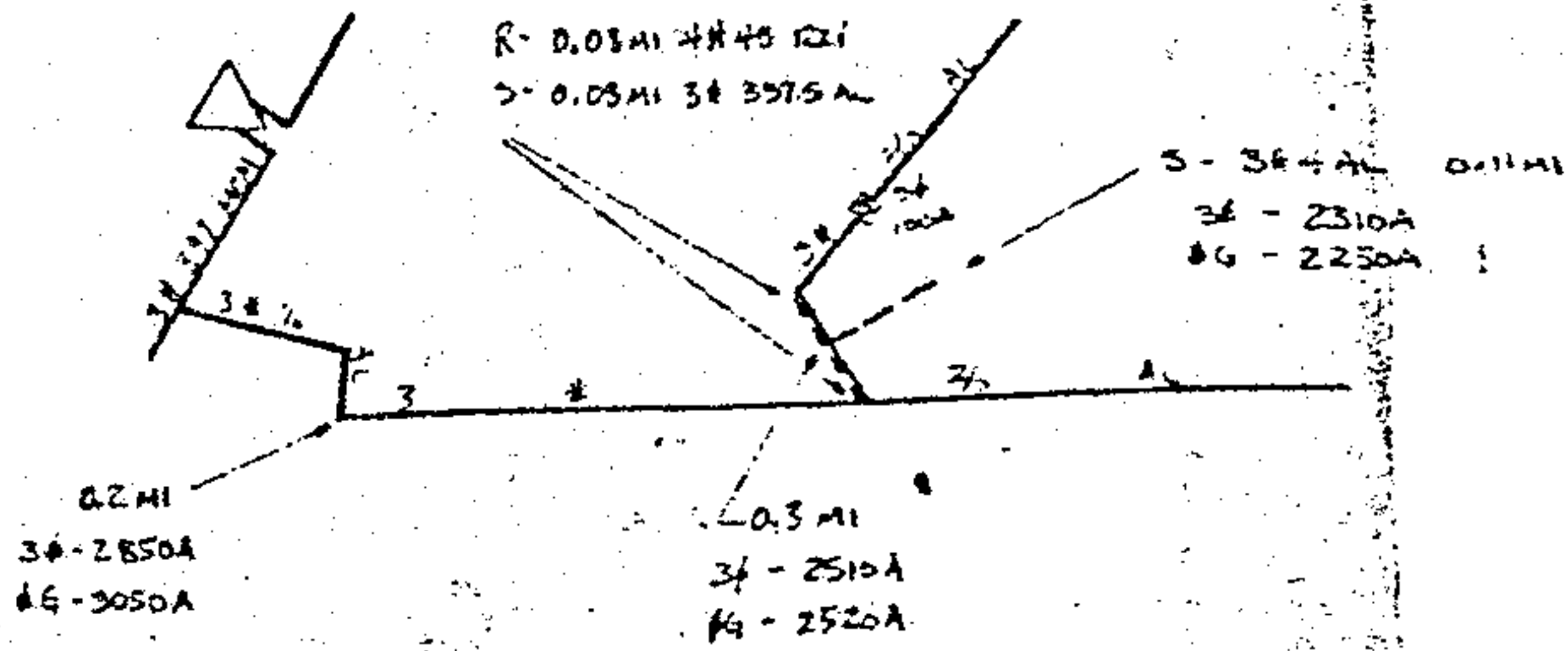

NOTE: MILE POINTS GIVE DISTANCE FROM SUB OR LAST MILE POINT

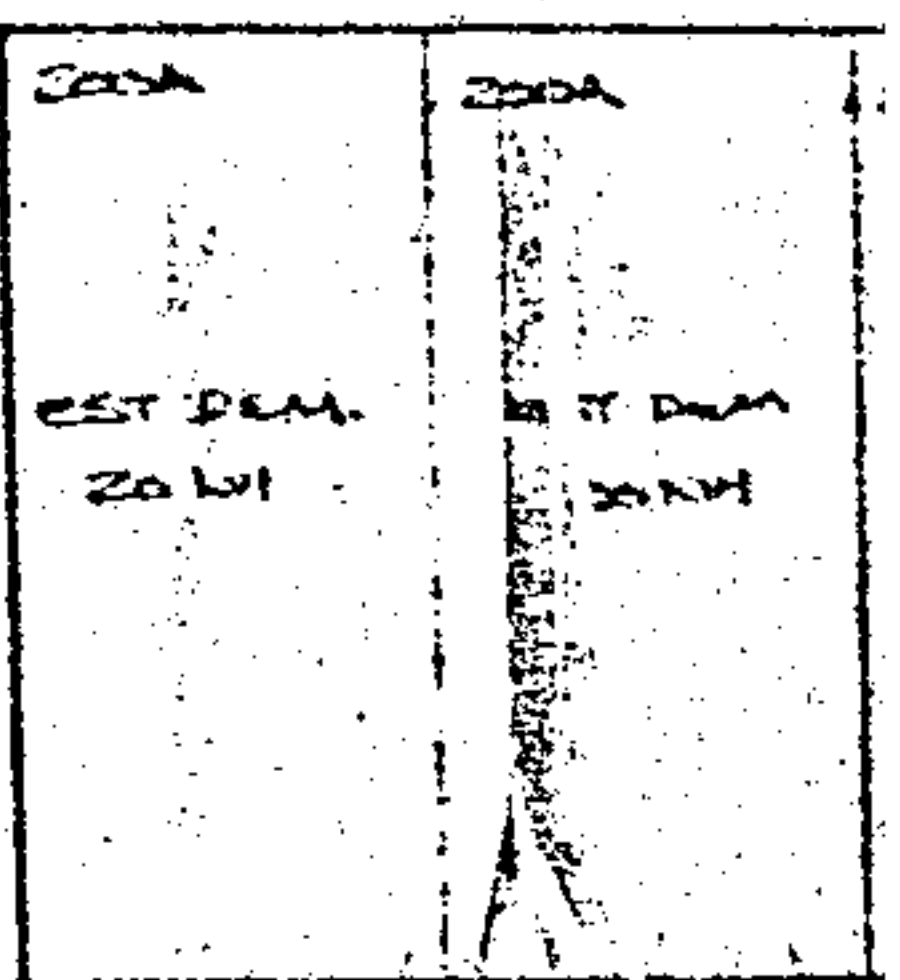


SECTIONALIZING DIAGRAM

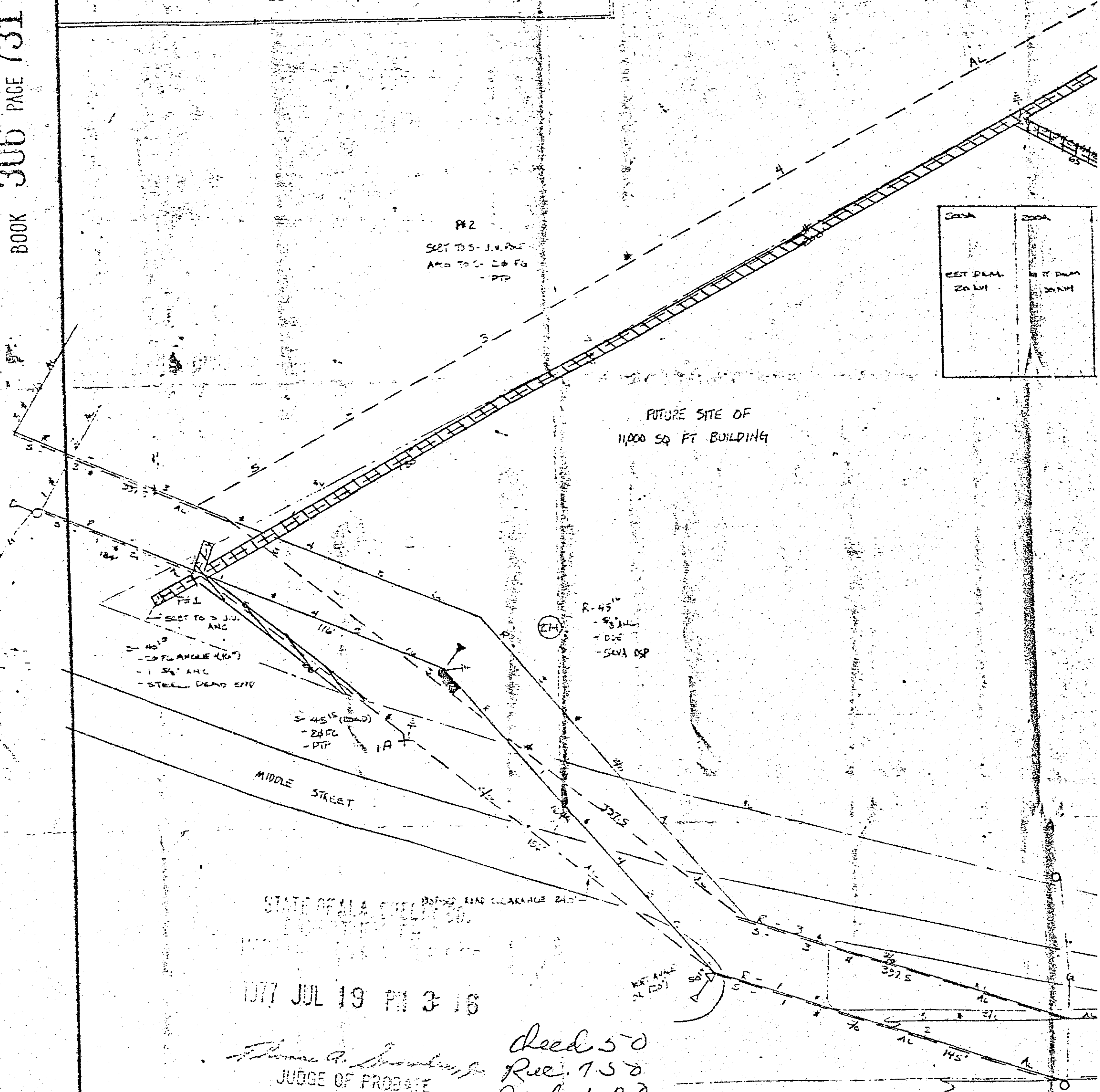
