

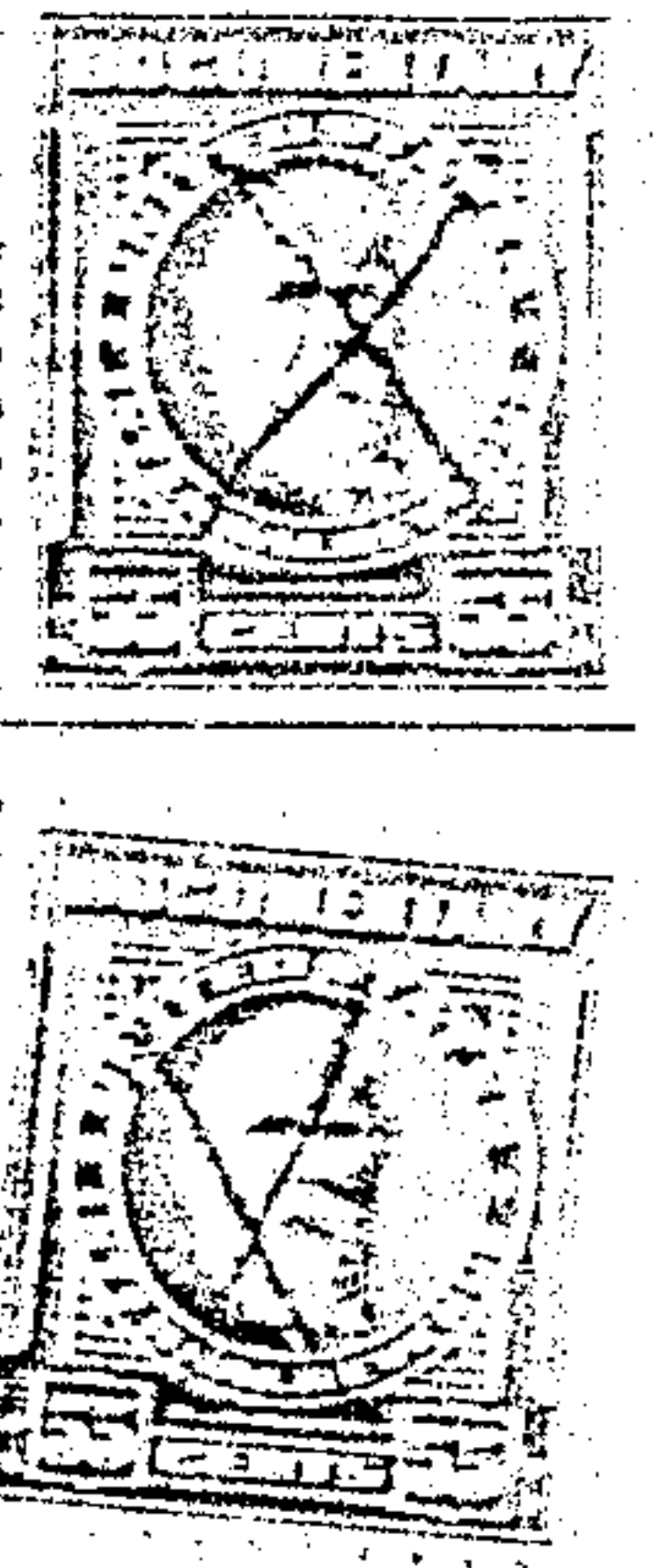

Cather, the following described real estate, situate, lying and being in Shelby County, Alabama, to-wit:
