KNOW ALL MEN BY THESE PRESENTS; That,

For and in consideration of One Dollar (\$1.00) and other good and valuable considerations to it in hand paid, the receipt whereof is hereby acknowledged, the undersigned CITY NATIONAL BANK OF BIRMINGHAM, A National Banking Association, does hereby release and discharge from the lien of that certain mortgage executed by Leigh B. Hutson and husband Hosey Hutson dated October 14, 1976, recorded in Volume 358, page 798, Probate Records of ~~Jefferson~~ ^{Shelby} County, Alabama, the following described property:
