Commence at the southeast corner of the N.W. 1/4 of the S.W. 1/4 Section 7, Township 19,S., Range 1W.; thence north along the east line of said quarter 322.4 feet, to a 2" capped pipe, the point of beginning; thence continue along the east line of said quarter 664.72 feet; thence an angle to the left of 91°36'30" and run 745.20 feet to the scutherly Right of way line of Cahaba Valley Road; thence an angle to the left of 46°22' and run 23.20 feet along said Right of way line; thence an angle to the right of 1°28' and run 929.13 feet along said Right of way line; thence an angle to the left of 91°23'30" and run 371.98 feet; thence an angle to the left of 84°09'30" and run 409.41 feet; thence an angle to the right of 40°27' and run 820.70 feet, to the point of beginning.
