Garrison and wife, Gloria Marie Garrison, do hereby grant, bargain, sell and convey unto the Grantee, a permanent easement or right-of-way for access to and from the property of the Grantors, including all rights and privileges necessary or convenient for the full enjoyment of the use thereof, over, across and upon a certain strip of land, described as follows:

The West 25 feet, more or less, (but not to exceed the maximum width of the Chert Road hereinafter referred to) of the South 999.18 feet of the NW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 12, Township 18 South, Range 1 East, situated in Shelby County, Alabama.

TO HAVE AND TO HOLD unto the said Ramolisa Corporation, its successors and assigns forever, warranted free and clear of liens and encumbrances.

It is understood and agreed that the foregoing right-of-way has been surveyed by Evander E. Peavy, Civil Engineer and Licensed Surveyor, by Survey dated June 14, 1977 and it is the intention of this conveyance to convey to the Grantee (its successors and assigns) a permanent right to use that part of the existing Chert Road as presently laid out by said Survey and located on the land of the Grantors, for ingress and egress to and from the property owned by said Grantee, to-wit,

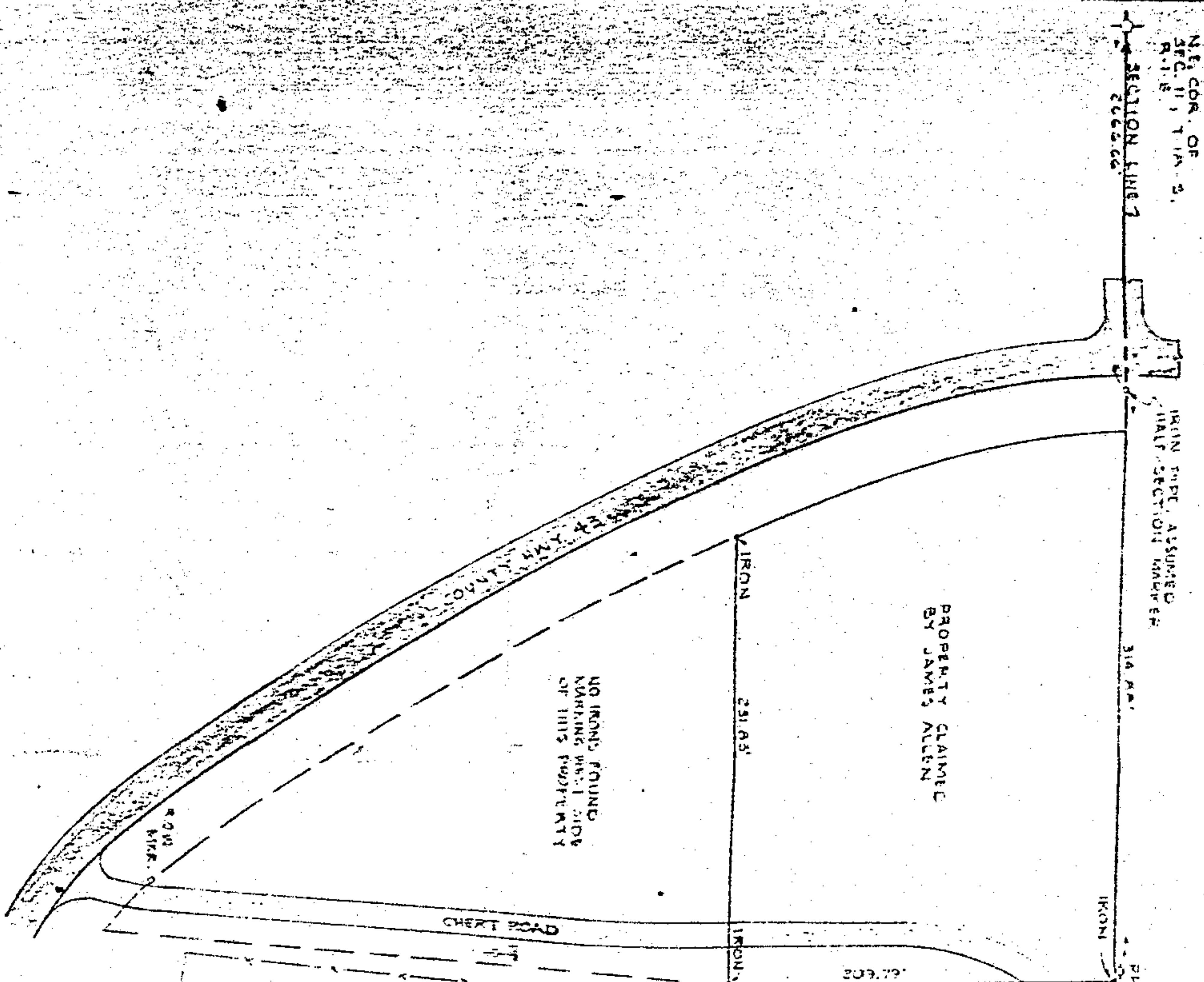
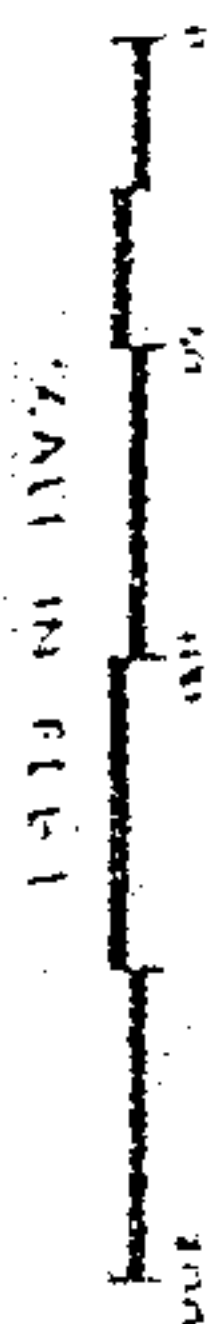
