MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That, WHEREAS, heretofore, on, to-wit, July 17, 1972, William T. McCartney and wife, Cordelia McCartney, executed a certain mortgage on property hereinafter described to H & H Construction Company, Inc., a Corporation, which said mortgage is recorded in Mortgage Book 324 at Page 685 in the Office of the Judge of Probate of Shelby County, Alabama;

WHEREAS, in and by said mortgage, the Mortgagees were authorized and empowered in case of default in the payment of the indebtedness thereby secured, according to the terms thereof, to sell said property before the Courthouse door in Columbiana, Shelby County, Alabama, after giving notice of the time, place and terms of said sale in some newspaper published in said Shelby County, Alabama, by publication once a week for four successive weeks prior to said sale at public outcry, for cash, to the highest bidder, and said mortgage provided that in case of sale, the Mortgagee or person conducting said sale was authorized to execute a deed conveying title to the purchaser at said sale; and it was further provided in and by said mortgage that the Mortgagee could bid at the sale and purchase said property if the highest bidder therefor; and,

WHEREAS, default was made in the payment of the indebtedness secured by said mortgage, and the said H & H Construction Company, Inc., a Corporation, did declare all of the indebtedness secured by said mortgage due and payable, and said mortgage subject to foreclosure as therein provided, and did give due and proper notice of the foreclosure of said mortgage by publication in the Shelby County Reporter, a newspaper published in Shelby County, Alabama, and of general circulation in Shelby County, Alabama, in the issues July 7, July 14, July 21, and July 28, 1977; and,

WHEREAS, on August 5, 1977, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly and properly conducted, and H & H Construction Company, Inc., a Corporation, as Mortgagee, did offer for sale and sell at public outcry in front of the Courthouse door of the Shelby County Courthouse in Columbiana, Alabama, the property hereinafter described; and,

WHEREAS, Michael E. Gurley was the Auctioneer who conducted said foreclosure sale and was the person conducting said sale for the said H & H Construction Company, Inc., a Corporation; and,

WHEREAS, the highest and best bid for the property described in the aforementioned mortgage was the bid of H & H Construction Company, Inc., a Corporation, in the amount of Ten Thousand One Hundred Twenty-Five and 50/100 (\$10,125.50) Dollars, which sum of money the said H & H Construction Company, Inc., a Corporation offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to H & H Construction Company, Inc., a Corporation;


