The undersigned Anniston Production Association, a Corporation, does hereby Re-
lease from that certain mortgage heretofore executed by Cecil E. Burney, Jr. and
wife, Lucretia D. and Cecil E. Burney and wife, Frances Ann recorded in Book, 353;
Page 749 of the mortgage record of the Judge of Probate, Shelby County, Alabama
the following described Real Property:

Parcel I of land described as follows: Beginning at the Northeast corner of the
NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 27, Township 19, Range 1 East and run 310 feet South for a
point of beginning, thence West 100 feet to a point; thence South 60 feet to a
point; thence West 633 feet, more or less to the Northeast corner of the W.S. and
Lessie Elliott lot; thence along said east line of said Elliott lot run South 210
feet; thence along the South line of said Elliott lot run West 210 feet to the
Southeast corner of Revie Ray lot, said point of being the center of a branch,
thence along the center of said branch and the meanderings of same run in a
Southeasterly direction 954 feet, more or less, to the East line of said forty
acres; thence North 562 feet, more or less, to the point of beginning.

Also a parcel of land described as follows; That part of the NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of
Section 27, Township 19, Range 1 East described as beginning at a ditch on the
East side of Hoyt Lybrand's lot; run thence South 29 degrees West along Lybrand
line 110 feet; thence run South 53 degrees 20 minutes East 280.1 feet; run thence
North 36 degrees East 163 feet to branch; run thence Northwesterly along said
branch 283 feet more or less to the point of beginning, containing 1 acre, more
or less. Also begin at the Northeast corner of NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 27, Township
19, Range 1 East and run South a distance of 310 feet; thence West 100 feet to
a point; thence South 60 feet to a point; thence West 633 feet; more or less
to the Northeast corner of a formerly owned lot of W.S. and Lessie Elliott to the
point of beginning. Thence continue in the same direction 210 feet to a point
just West of the West right of way line of the Lybrand road; thence South 40 feet;
thence Southeast 213 feet, more or less to a point on the West line of Ray H. and
Barbara Moore land; which point is 100 feet South of the point of beginning;
thence run North along the West line of said Moore lot 100 feet to the point of
beginning. Above described lands situated in Shelby County, Alabama.

remain in full force and effect. This instrument shall not be construed to
release any property other than the above described from said mortgage.
